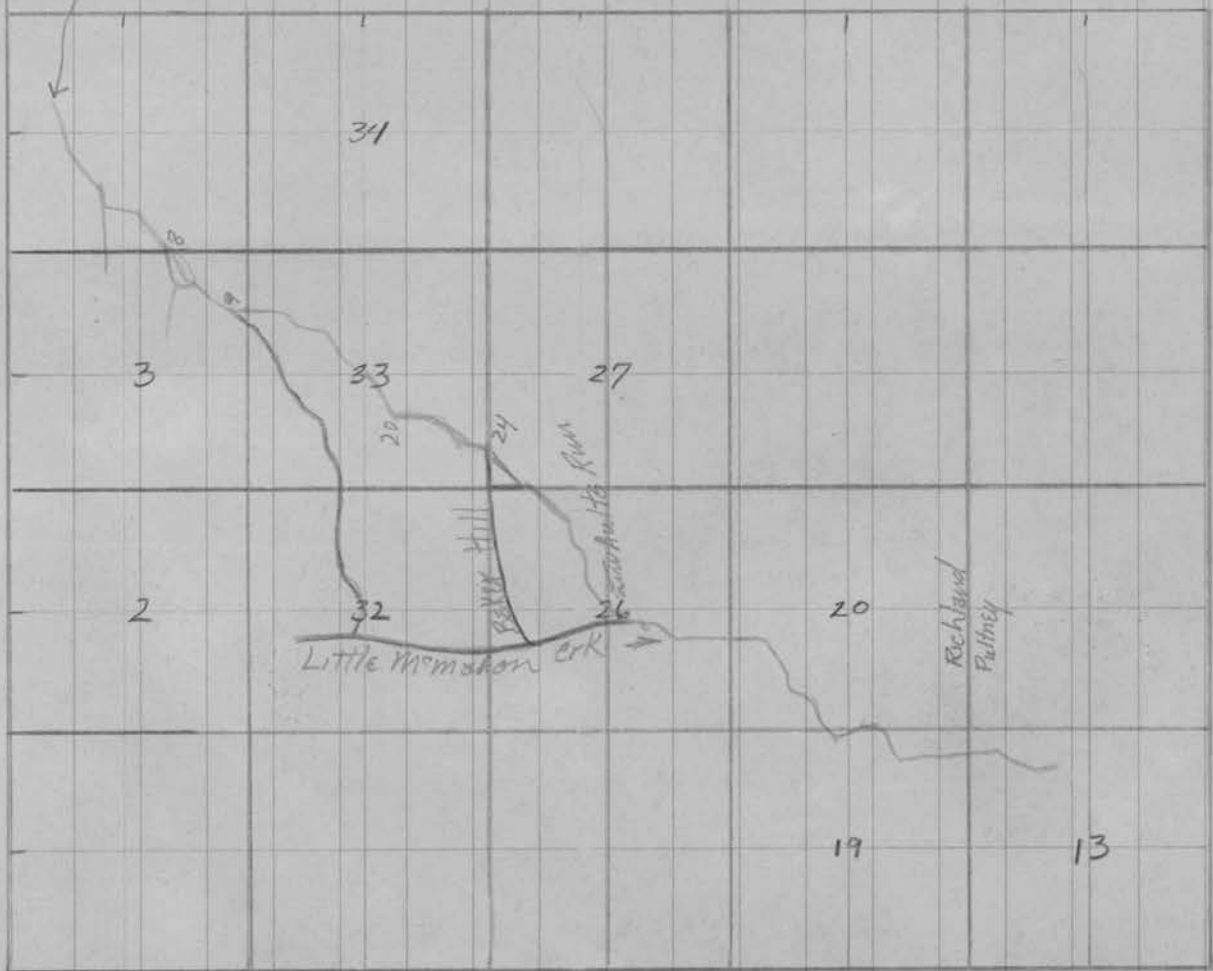

Surveyor's Report.

To the Board of Commissioners of Belmont County, Ohio.

The undersigned, in obedience to your order, dated March 1876

proceeded on the 27th day of April 1876 to survey and mark the line of the "Old Road" described in said order, under the direction of the viewers therein named, and respectfully submits the following return of

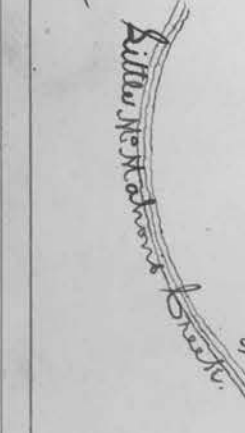
said survey:

The full "Black line" indicates the line as then and stated by me for the original line of the Road damaged in 1813. The full and dotted "Red lines" indicate that lines then by me in 1813. The dotted black line from Echols' mill to Bull's Run is a line recommended by viewers, instead of the old line.

From Station 40, Red Oak, brass. S. 79° E. 6.40 rods.
 From Station 40, Sta 2, De Hass, Alteration, brass S. 71° E. 3.10 rods.
 From Sta 2, De Hass Alteration, Red Oak, brass. S. 86 1/2° E. 3.40 rods.

The line from Sta 40 to 61, inclusive = old line from Bull's Run to Echols' mill - the dotted black line from Echols' mill to Bull's Run, Stations 1 and 33 inclusive = line recommended by viewers, instead of the old line.

Notes of the "Old Line":



From Station 40, Red Oak, brass. S. 79° E. 6.40 rods.
 From Station 40, Sta 2, De Hass, Alteration, brass S. 71° E. 3.10 rods.
 From Sta 2, De Hass Alteration, Red Oak, brass. S. 86 1/2° E. 3.40 rods.

The line from Sta 40 to 61, inclusive = old line from Bull's Run to Echols' mill - the dotted black line from Echols' mill to Bull's Run, Stations 1 and 33 inclusive = line recommended by viewers, instead of the old line.
