For a Alteration Road in Richland Co

To the Board of Commissioners of Belmont County, Ohio:

The undersigned petitioners, resident freeholders of said county, respectfully represent that the public convenience requires the Alteration of a County road on the line hereinafter described; and pray that your body will institute and order the proper proceedings in the premises to Establish such change in such road, to-wit: Beginning at The north west corner of a granary on the farm of Joseph Ddings on said road, and running thence in a North Easterly direction toward and to the nearest practicable point of the line of the lands of Geo Ddings. Thence down the line of said Geo Ddings land until it meets said road as now Established thence along the present bed of said road to the South west corner of Sec 17 when it strikes the road leading to Harisville. Thence across said Harisville road due West along the line between the lands of Robert Thompson and Wm Clark until it intersects the Uniontown Road, and your petitioners also ask that said Uniontown Road may be vacated from said point of intersection to the point where said Uniontown road now meets the road leading to Harisville

Thence along the present bed of said road to the South West corner of Sec. 17, when it strikes the road leading to Harisville. Thence across said Harisville road due West along the line between the lands of Robt. Thompson and William Clark until it intersects the Uniontown Road. And your petitioners also ask that said Uniontown Road may be vacated from said point of intersection to the point where said Uniontown Road now meets the road leading to Harisville



REPORT OF VIEWERS.

To the Board of Commissioners of Belmont County, Ohio:

In obedience to your order, issued at your September session, A. D. 1874, we, the undersigned, Viewers appointed under said order, met with Noble Carter Surveyor, at Jos Sodge on 29th September and were severally sworn to discharge, faithfully and impartially the duties required of us in said order.

If any viewer is unable to attend, here state by whom the vacancy was filled.

Jos Smith and Saml Clark were selected by us as chain carriers, and Anton Fields as a marker, who were also duly sworn.

We then proceeded to view said proposed Alteration on the line described in your order, and caused the same to be surveyed "as prayed for in the petition, or as near the same as in our opinion a good road can be made at a reasonable expense, taking into consideration the utility, convenience, and inconvenience and expense which will result to individuals as well as the public," by the Alteration of said road as follows:

We would respectfully report that the said Alteration ought to be made for the following reasons:

First that a better road can be made than when it was originally surveyed, because that it will require less fencing than now,

We have also determined that the public convenience requires that such Road shall be established 36 feet in width.
