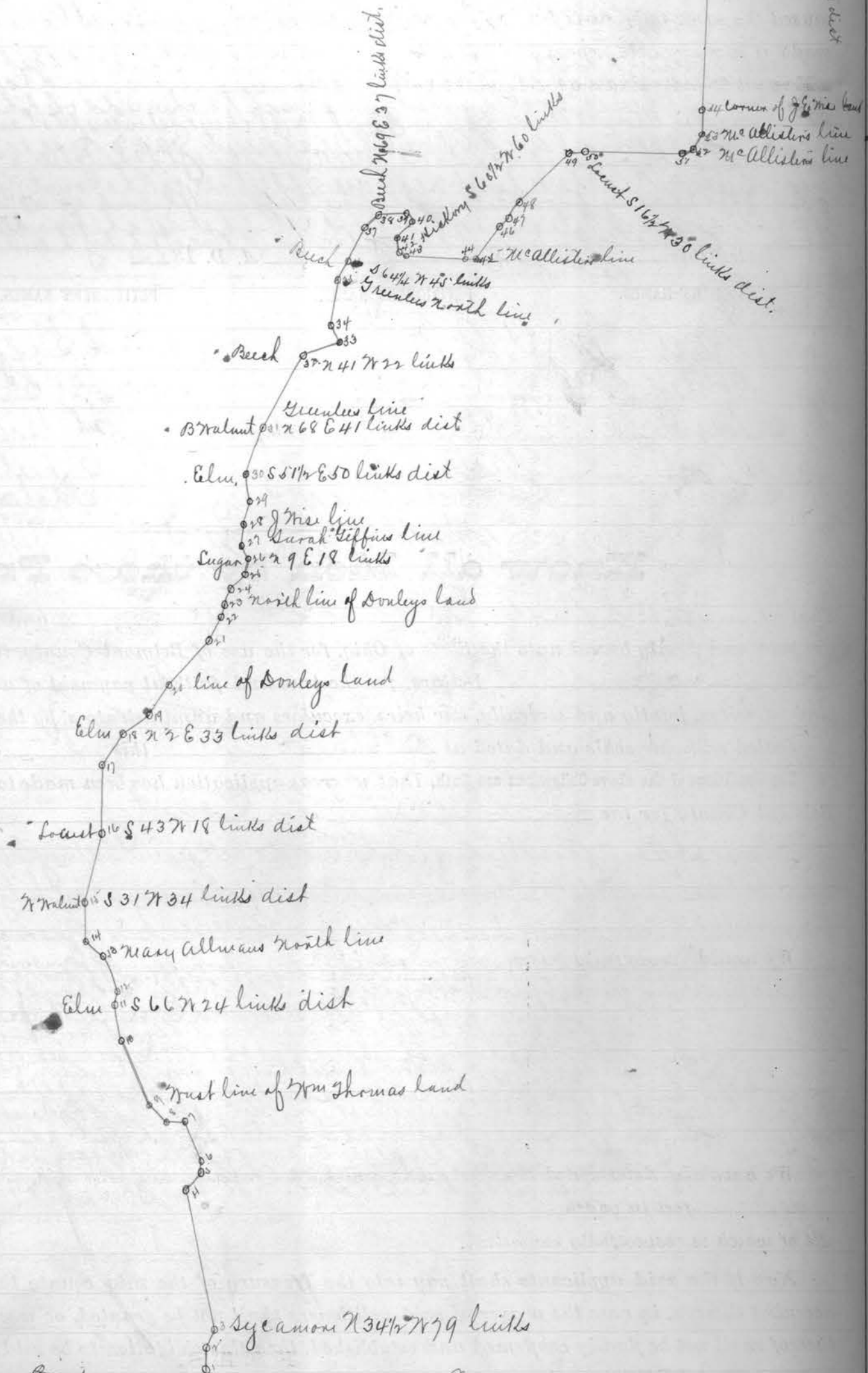

REPORT OF VIEWERS.

To the Board of Commissioners of Belmont County, Ohio:

In obedience to your order, issued at your March session, A. D. 1883, we the undersigned, Viewers appointed under said order, met with John A. Mitchell Surveyor, at Wm Thomas's Residence on April 12th 1883 and were severally sworn to discharge, faithfully and impartially the duties required of us in said order.

If any viewer is unable to attend, here state by whom the vacancy was filled.

Jas. Giffin and Gilbert Nilson were selected by us as chain carriers, and D. F. McCoy as a marker, who were also duly sworn.

We then proceeded to view said proposed County Road on the line described in your order, and caused the same to be surveyed, "as prayed for in the petition, or as near the same as in our opinion a good road can be made at a reasonable expense, taking into consideration the utility, convenience, and inconvenience and expense which will result to individuals as well as the public," by the establishment of said road as follows:

Beginning on the County road leading from Gleason to Bellair in Pullney township, Belmont Co., O. near a bridge on the lands of Wm Thomas; thence by the courses and distances on the Surveyors flat, which is made a part of this report, and for a more particular description of said road reference is here made to said flat.

We would respectfully report that the said County Road ought to be established for the following reasons: 1st It will be of the greatest public utility, and general and public advantage and convenience; 2d. It can be established at a reasonable expense taking into consideration the utility & convenience which will result to the traveling public as well as individuals on the line of said road; 3d that because the public convenience requires, and a good road can be made along the line surveyed at a small expense of money and labor

We have also determined that the public convenience requires that such County Road shall be established 30 feet in width, except between stations 38 & 41 also between stations 51 & 53 which is 50 feet wide.

For an alteration of County Road in Mead Township

To the Board of Commissioners of Belmont County, Ohio:
