## ROAD PETITION

For the Alteration and change of a Road in Richland Township,  
Improvement No. 138 Petitioned for by C. Ray Morgan and Others.

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the Alteration and change of a Public Road on the line hereinafter described; and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning at The alteration and change of location hereby petitioned for is a part of the public road known as the Jug Run Road in Richland Township of said County and leading northeast from the St. Clairsville-Cadiz Pike at Provident and down the stream known as Jug Run. Beginning for the change and alteration thereof in the middle of said Jug Run Road at or near the dwelling house on the land belonging to the Heirs of John Reline, deceased said land being in the S. W. Quarter of Section 6, Township 7, and Range 4; thence in an northeasterly direction and on the South side of Jug Run Creek for a distance of about 1500 feet to a point in the center of the said Jug Run Road, and nearly opposite the stable on the land or lot of one Tony Yaskus. Said alteration and change being on and through the lands of the said Heirs of John Reline, deceased, and the land of said Tony Yaskus.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the Belmont Chronicle a newspaper published and having a general circulation in the County of Belmont.
