ROAD PETITION

For the alteration of a Road in Warren Township, Improvement No. 150 Petitioned for by W. S. Todd and Others.

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the alteration of a Public Road on the line hereinafter described; and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning

Where the public road leads west from the Barnesville and Fairview road and runs in a westerly direction into Guernsey County, we respectfully ask that this road be changed so that it will leave the Fairview road some 300 ft. South of the present intersection and then cross the old roadway in a northwesterly direction through the lands of Geo. Wildes until reaching the bottom of the hill. Purpose of this change being to eliminate as much as possible the present heavy grade through the Wildes land onto the Barnesville & Fairview road.

in the matter of the alteration of the public road, petitioned for by W. S. Todd and others, due and proper notice, proof of which is on file in this office, having been given of the time and place of meeting, to view road petitioned for by W. S. Todd

and others, in the Barnesville Enterprise, a newspaper of general circulation in said county required by law, and the former orders of this Board, the Commissioners on this 11th day of March 1924, met at the time and place in said notice designated and did view

SURVEYOR'S REPORT ON ROAD

Surveyor's Office, Belmont County,

To the Board of Commissioners of Belmont County, Ohio:

St. Clairsville, Ohio, May 15, 1924

Pursuant to your order dated April 7, 1924, I make my report to you as follows, in the matter of the alteration of the public road petitioned for by W. S. Todd and others.

1. My opinion is the granting of the improvement; but with the following changes, which in my judgment should be made, to-wit: No. 150 or Geo. W. Wildes road is for the betterment of the road system of Belmont County
2. The width should be 40 feet as it will require 40 ft. for the side slopes. The upper end requires 3-12" corrugated culverts.
3. Estimated compensation and damages, due each person, firm or corporation (with a * before the name of each minor or other person under disability), to-wit:

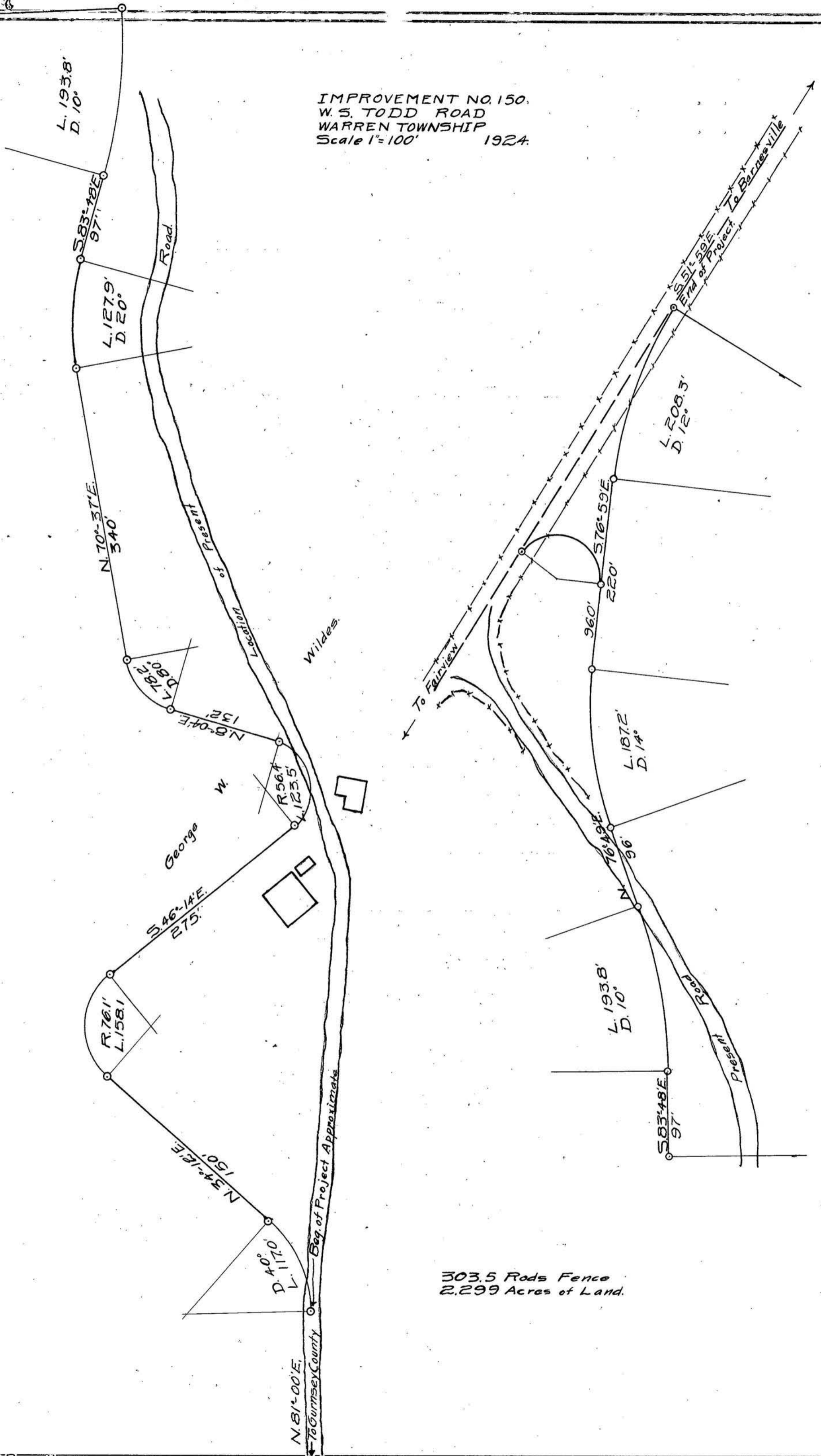
