**SURVEYOR'S REPORT ON ROAD**

Surveyor's Office, Belmont County,

To the Board of Commissioners of Belmont County, Ohio:

St. Clairsville, Ohio, June 19, 19 24

Pursuant to your order dated June 17, 19 24, I make my report to you as follows, in the matter of the relocation of the public road petitioned for by A. J. Murphy and others.

1. My opinion is that the granting of the improvement; but with the following changes, which in my judgment should be made, to-wit: greatly reduces the grade on two hills and still gives good alignment
2. The width should be 30 feet to conform to the rest of the road.
3. Estimated compensation and damages, due each person, firm or corporation (with a \* before the name of each minor or other person under disability), to-wit:

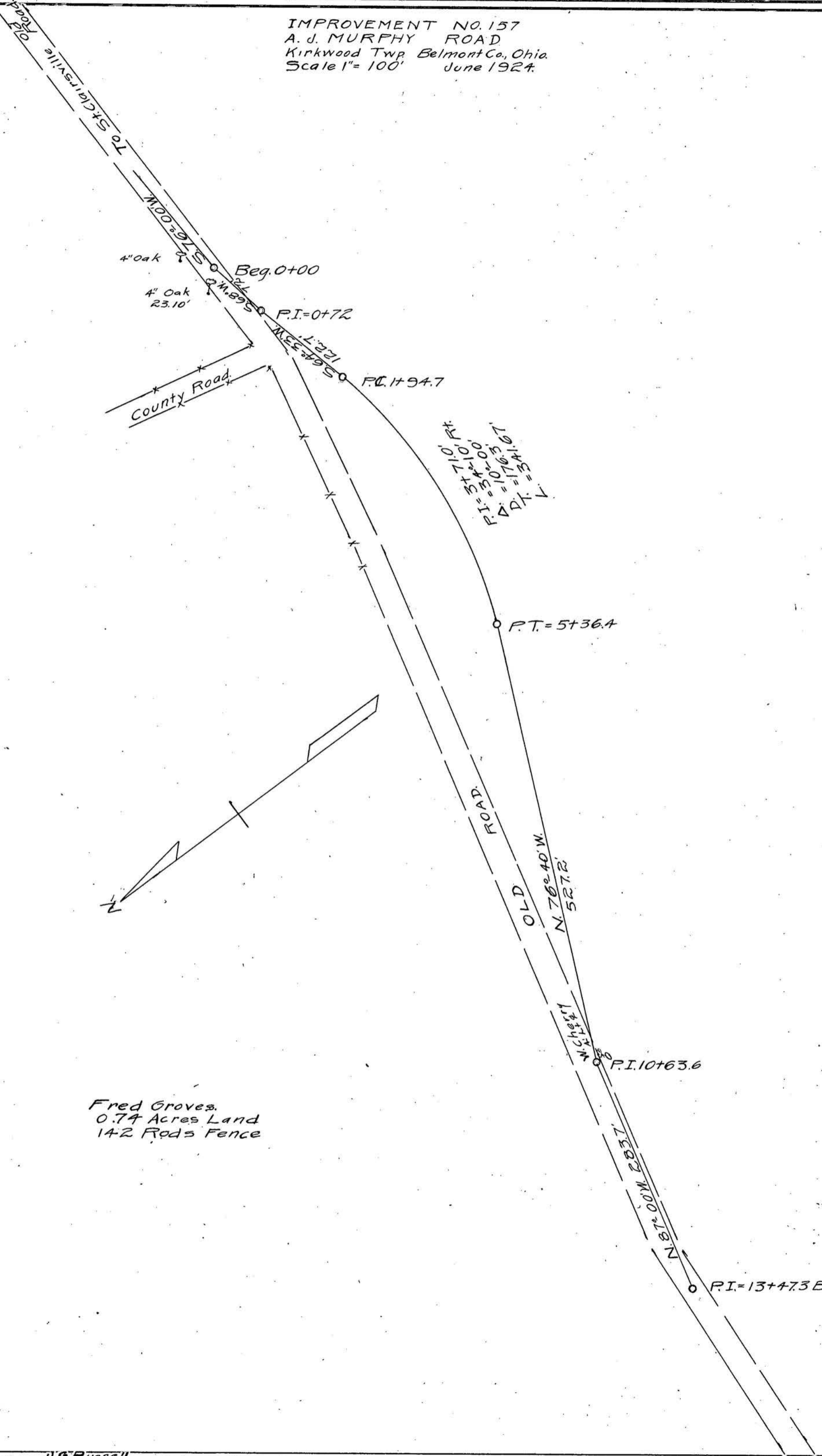
