Pursuant to your order dated _____, 1924, I make my report to you as follows, in the matter of the alteration, etc. of the public road petitioned for by O. D. Keyser and others.

1. My opinion is that the granting of the improvement; but with the following changes, which in my judgment should be made, to-wit: is all O. K. as the County destroyed their approach and road in the construction of the McMahons creek road. Therefore this is a substitute for the one destroyed.
2. The width should be 30 feet destroyed.

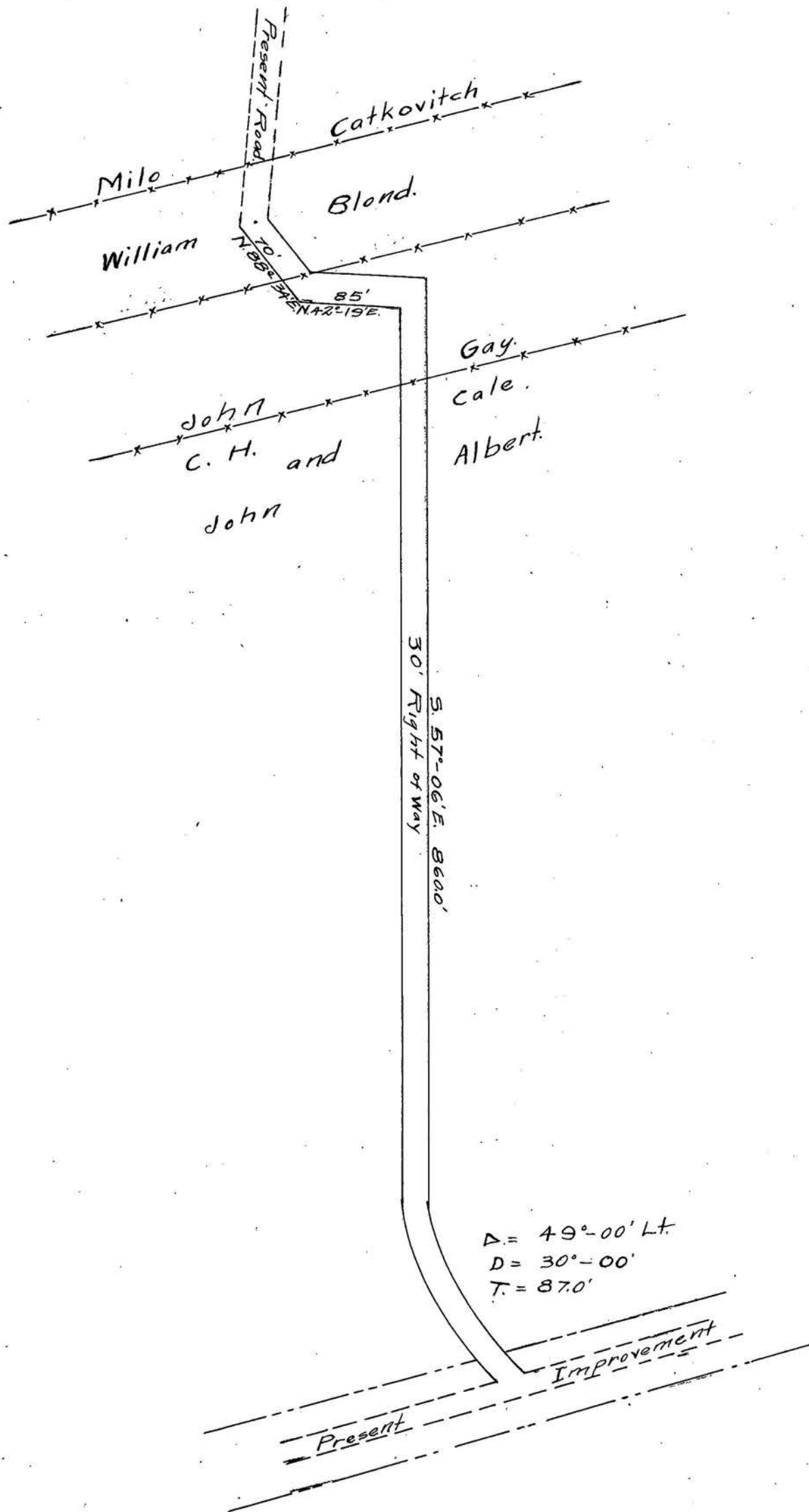
