The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the alteration & improvement of a Public Road on the line hereinafter described; and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning At Pultney Road at School House Number 7 of Warren Township, Belmont County, near the Section line between Section 27 and 28 running thence South to the forks of the public road at the Southeast corner of John Hunkler's; thence in a westerly direction between the lands of John Hunkler and Martin Merritt to the Section line between Section 27 and 33; thence in a westerly direction thru the lands of Jacob Reischman, Ben Price, Edward and Ella Boyd to the Belmont-Guernsey County line.

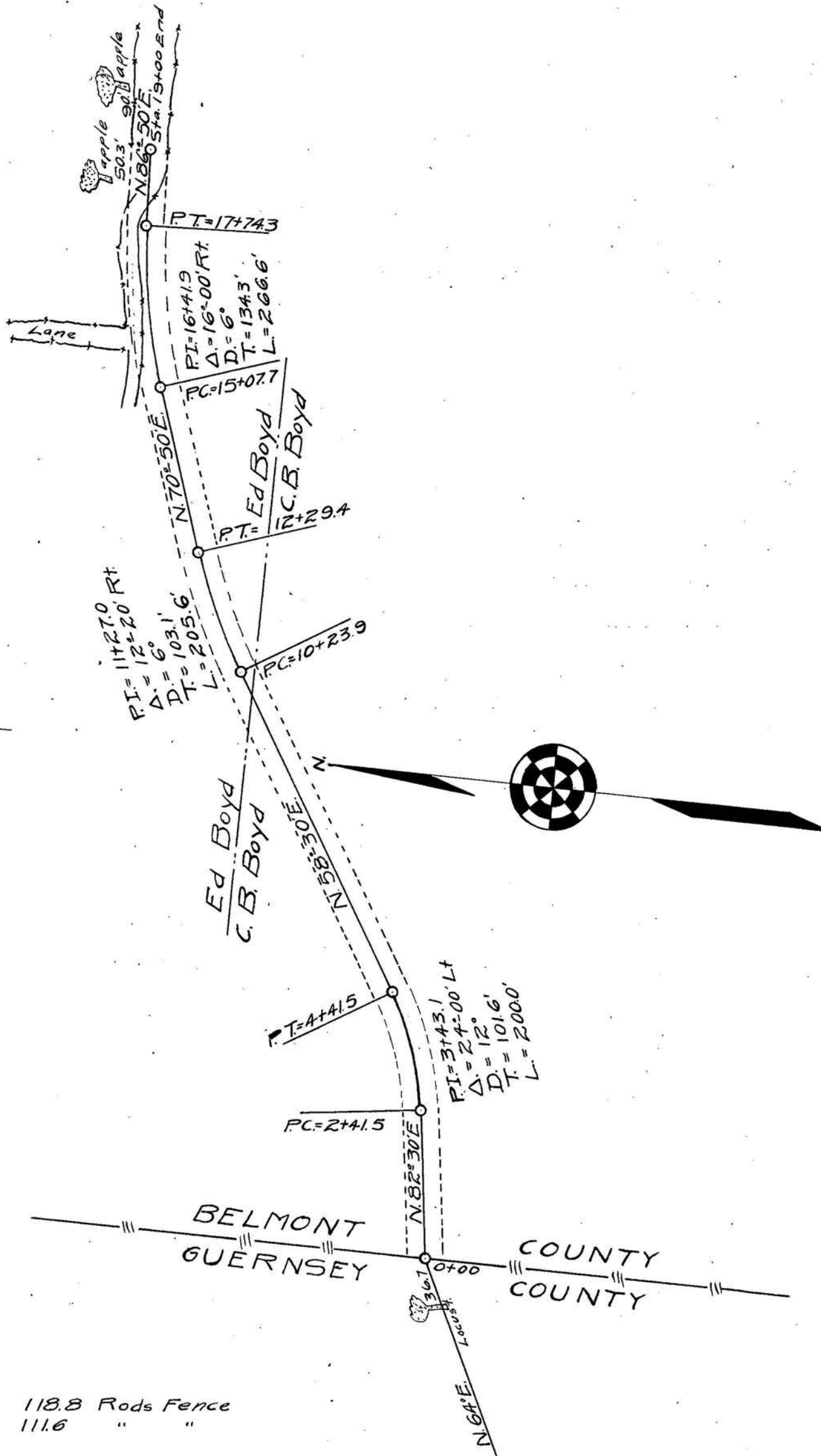
