

### ROAD PETITION

For the Alteration of a Road in Goshen Township Township,  
Improvement No. 48 Petitioned for by D. F. Barrackman and Others.

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the Alteration of a Public Road on the line hereinafter described; and pray that you will institute and order the proper proceedings for said improvement, to-wit: *Beginning* at a point in the Barnesville and St. Clairsville road about 200 feet east of the residence of Harley Hunt; Thence in an easterly direction over the lands of H. & F. Gregg, and Nathan Shepherd, by the most practical route as approved by the County Engineer and Commissioners to a point in said road near the dwelling of Nathan Shepherd.

The conditions of the above obligation are such, that WHEREAS, application has been made by J. B. Lynn and others to the Board of Commissioners of the said Belmont County, for the Alteration of a public road, on briefly the following line, to-wit:

THEREFORE if, 1st. The petition be not granted; or if 2nd. The Commissioners shall order a portion of the compensation and damages to be paid by the petitioners, and the petitioners fail to pay same by the time fixed by the Commissioners: Then in either such case the said applicants will pay into the treasury of said County the COSTS AND EXPENSES incurred in the proceedings for said improvement.

The Board of Commissioners of Belmont County, Ohio, met this day in Special session, present J. R. Greenlee, A. J. Geller, and W. R. King Commissioners, and Bert W. Hopkins Auditor and Secretary of the Board, and it appearing that D. F. Barrackman and others, have filed a petition in the office of the Commissioners of the County, on the 13th day of May 1918 for the Alteration of a

public road, along the following route, to-wit: Beginning for the same at a point in the Barnesville and St. Clairsville road about 200 feet east of the residence of Harley Hunt thence in an easterly direction over the lands of H. & F. Gregg and Nathan Shepherd by the most practical route as approved by the County Engineer and Commissioners to a point in said road near the dwelling of Nathan Shepherd. Said Road being located in Goshen Township Belmont County, Ohio.

the same was this day considered by the Commissioners, and it appearing that said petition is regular and in conformity to law, and that the said D. F. Barrackman has filed herein a bond as required by law. It is ordered that the 18th day of June 1918 at 11:00 o'clock A.M. be fixed as a date to view the same, at which date they will meet at the Commencing Point and go over the route of said proposed road.

They also fixed the 22nd day of July 1918 at 1:00 o'clock P.M. as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the Barnesville Whetstone a newspaper published and having a general circulation in the County of Belmont.

Hopkins, Auditor and Secretary of the Board, and it appearing that in the matter of the Alteration of the public road, petitioned for by D. F. Barrackman and others, due and proper notice, proof of which is on file in this office, having been given of the time and place of meeting, to view the road petitioned for by D. F. Barrackman and others, in the Barneaville Whetstone, a newspaper of general circulation in said county as required by law, and the former orders of this Board, the commissioners on this 18th day of June 1918 met at the time and place in said notice designated, and did view the route of said proposed road improvement, and considering such improvement to be of sufficient public importance, it is ordered that the County Surveyor, make a plat and survey of the same and report to the Board in writing on or before the 22nd day of July 1918 the time set for the hearing, and shall set forth in said report his opinion either for or against the granting of such proposed improvement, accompanied with a statement of the estimated compensation and damages due each person, firm or corporation, whose land is to be taken, if the proposed improvement is established. Such report shall also state the width of said improvement, which shall not be less than 30 feet nor more than 60 feet, and also recommend any changes in the improvement, which in his judgment, should be made.

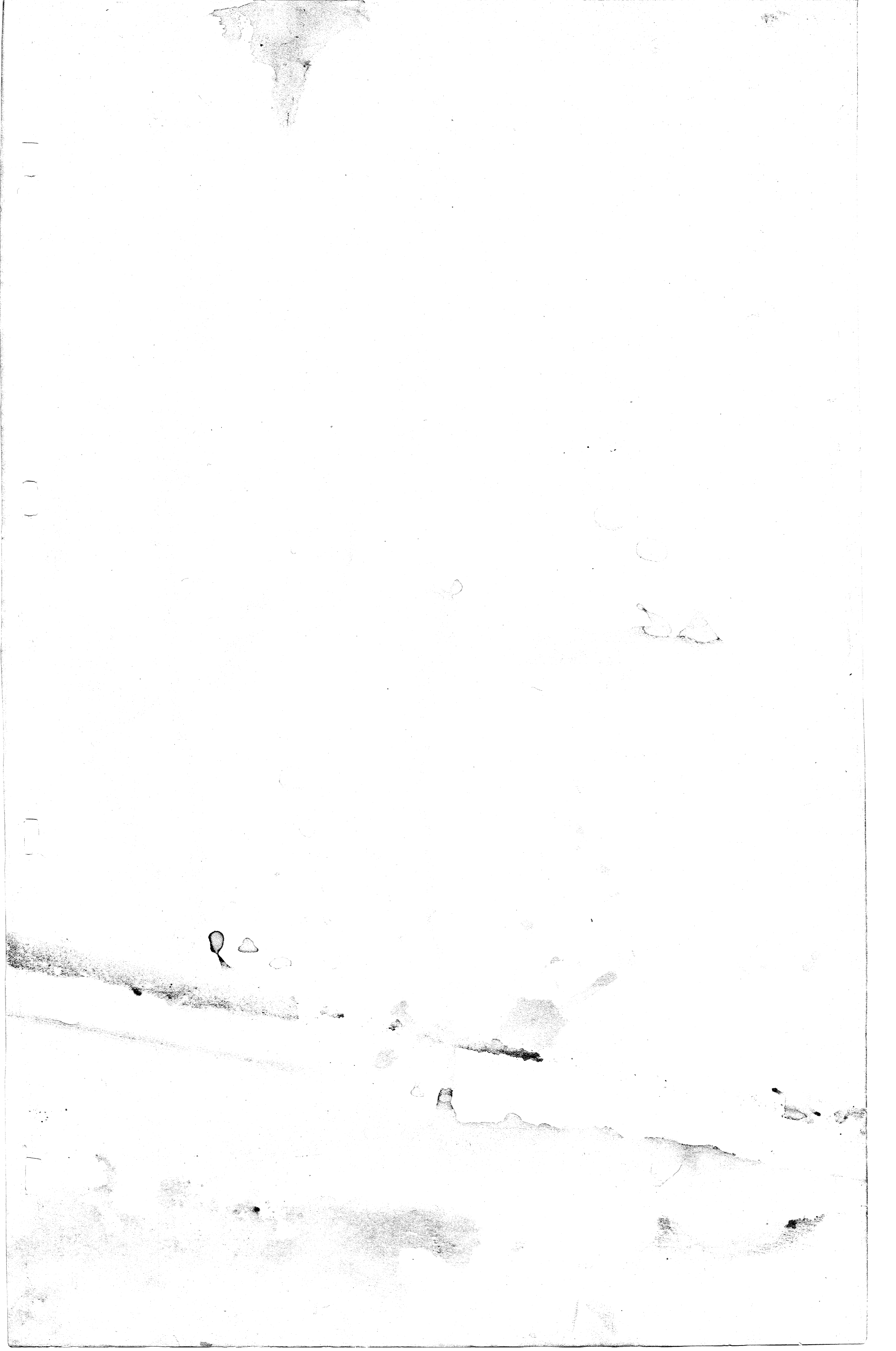

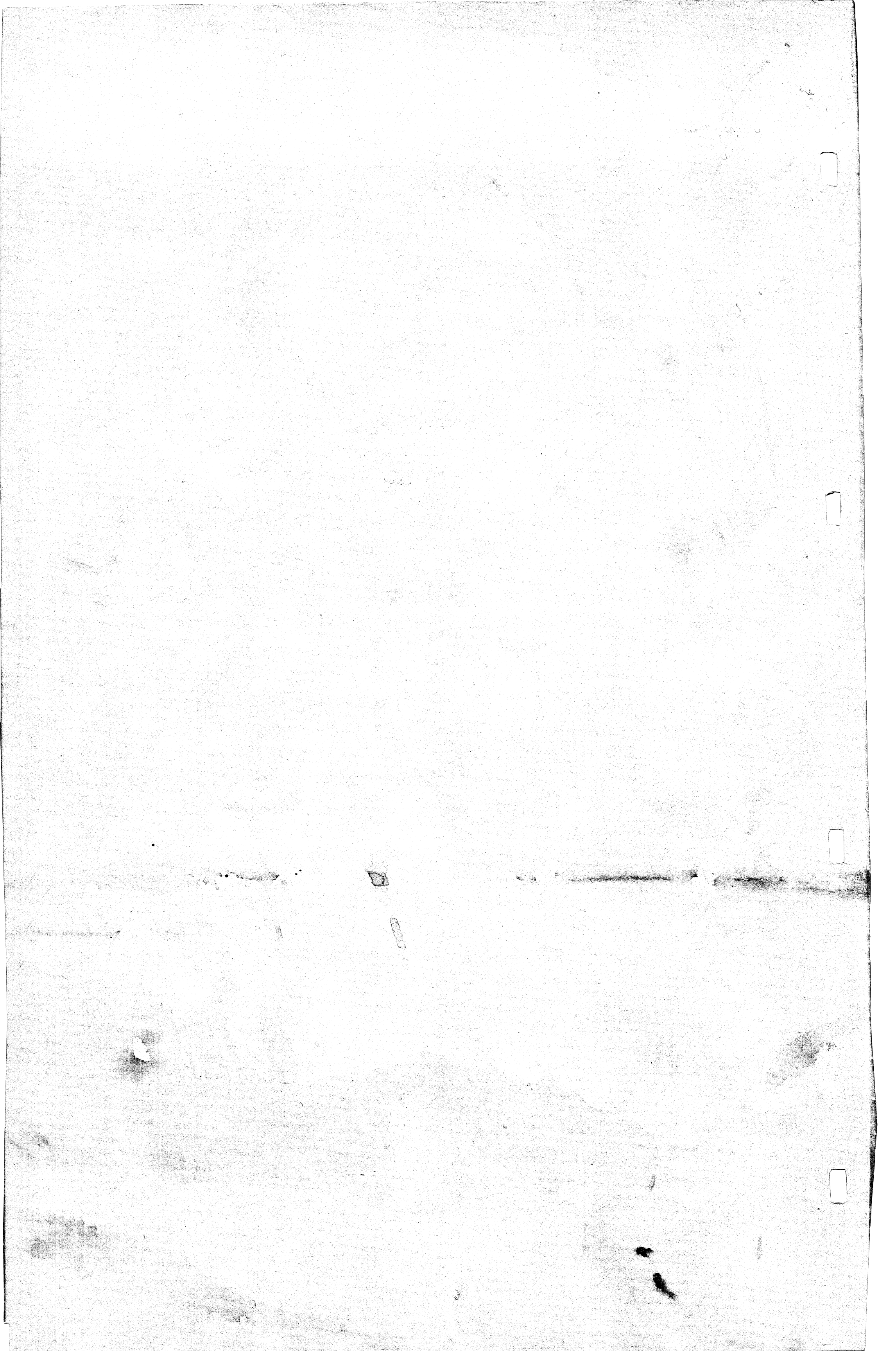
