

ROAD PETITION

For the Alteration of a Road in Smith Township,
Improvement No. 59 Petitioned for by J. K. Piper and Others.

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the Alteration of a Public Road on the line hereinafter described; and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning at a stake in the center of the Warnock & Lamira Road near the residence of J. K. Piper and running N. W. about 5 rods to a stake on the land of said J. K. Piper thence in a Northerly direction with the curve of the hill to a tree in the boundary line between the lands of said J. K. Piper and Clark Hutchinson. Thence N. of West following the curve of the hill to a stake at the top of the ridge on the lands of said Clark Hutchinson; thence N. of W. to a stake in the boundary line between the lands of said Clark Hutchinson and P. P. Russell. Thence across the corner of said P. P. Russell lands to a stake thence S. W. to a stake on the lands of P. P. Russell. Thence N. W. to a stake, thence west to a stake, thence S. of W. to a stake, near the boundary line between said P.P. Russell and the B. & O. R. R. Thence S. of W. along said line to a stake, thence S. of W. to and ending at a stake in the center of the Warnock & Lamira Road.

The conditions of the above obligation are such, that WHEREAS, application has been made by J. K. Piper and others to the Board of Commissioners of the said Belmont County, for the Alteration of a public road, on briefly the following line, to-wit:

THEREFORE if, 1st. The petition be not granted; or if 2nd. The Commissioners shall order a portion of the compensation and damages to be paid by the petitioners, and the petitioners fail to pay same by the time fixed by the Commissioners: Then in either such case the said applicants will pay into the treasury of said County the COSTS AND EXPENSES incurred in the proceedings for said improvement.

They also fixed the 21st day of April 1919 at 1 o'clock P.M. as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the The Gazette a newspaper published and having a general circulation in the County of Belmont.

Such report shall also state the width of said improvement, which shall not be less than 30 feet nor more than 60 feet, and also recommend any changes in the improvement, which in his judgment, should be made.

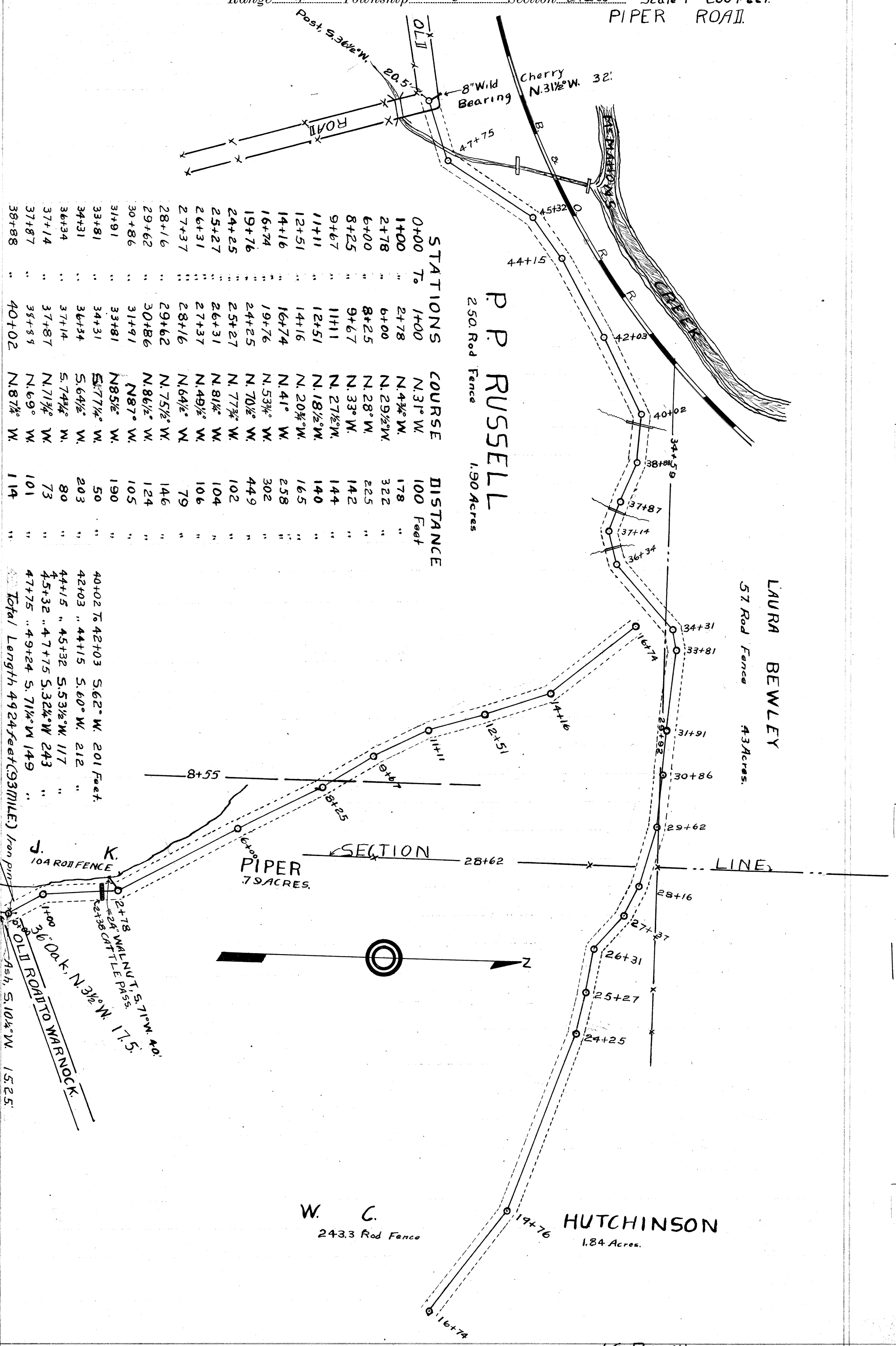

Range 4 Township 6 Section 24 & 30 Scale 1" = 200 Feet

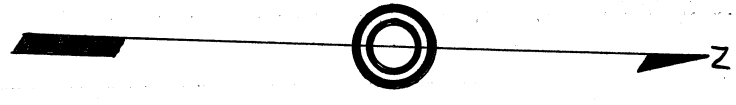

The Board of Commissioners of Belmont County, Ohio, met this day in Special session, present J. R. Greenlee, A. J. Geller, and W. R. King Commissioners and Bert W. Hopkins Auditor and Secretary of the Board, and it appearing that in the matter of the Alteration of the public road, Improvement No. 59 petitioned for by J. K. Piper and others, this day this cause came on for hearing in the matter of award of compensation and damages to adjoining landowners and the commissioners find that notice of the time and place of this hearing has been given to all the owners of land taken for such improvement or abutting thereon, as provided by law, and the former orders herein. That after hearing all applications for compensation and damages filed herein, and considering all claims of minors and those under disabilities, in the judgment of the commissioners there is awarded and due to the following persons the sums respectively opposite their names.

The Commissioners further find and are of the opinion that said improvement is of sufficient importance to the public for all of the Compensation and Damages to be paid from the County Treasury.

And it is ordered that the County Auditor draw his warrants on the County Treasury in favor of the above-named claimants for the amounts awarded them as aforesaid. It is further ordered that a record of the proceedings and the plat and survey be entered upon the road records of this County. It is further ordered that upon the compensation and damages being paid to the owners as above herein ordered, that the public road, as shown by the surveyor's report and plat, be opened up and established, and shall thereafter be a public road to be kept and maintained and improved as provided by law.

It is further ordered that a record of the proceedings and the plat and survey be entered upon the road records of this County.
