

ROAD PETITION

For the Change and Alteration of a Road in Wheeling & Flushing Township,
Improvement No. 61 Petitioned for by R. M. Campbell and Others.

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the Change and Alteration of a Public Road on the line hereinafter described; and pray that you will institute and order the proper proceedings for said improvement, to-wit: *Beginning at the Watson Bridge in Wheeling Township at a small elm tree tunnng southwest through the lands of John H. Watson to a large elm tree, thence around the hill to a maple tree, then running west to a chestnut tree where you intersect the present road and traverse the present road to a white oak tree in Flushing Township, thence across the land of R. A. Eyle in a southern direction to a large poplar tree where you intersect the Flushing and Bannock Pike. The same was this day considered and it appearing that said petition is regular filed and in conformity to law that that the said R. M. Campbell has filed herein a bond a required by law.*

Hopkins, Auditor and Secretary of the Board, and it appearing that in the matter of the Change & Atleration of the public road, petitioned for by R. M. Campbell and others, due and proper notice, proof of which is on file in this office, having been given of the time and place of meeting, to view the road petitioned for by R. M. Campbell and others, in the Martins Ferry Times, a newspaper of general circulation in said county as required by law, and the former orders of this Board, the commissioners on this 13 day of April 1919 met at the time and place in said notice designated, and did view the route of said proposed road improvement, and considering such improvement to be of sufficient public importance, it is ordered that the County Surveyor, make a plat and survey of the same and report to the Board in writing on or before the 5 day of May 1919 the time set for the hearing, and shall set forth in said report his opinion either for or against the granting of such proposed improvement, accompanied with a statement of the estimated compensation and damages due each person, firm or corporation, whose land is to be taken, if the proposed improvement is established. Such report shall also state the width of said improvement, which shall not be less than 30 feet nor more than 60 feet, and also recommend any changes in the improvement, which in his judgment, should be made.

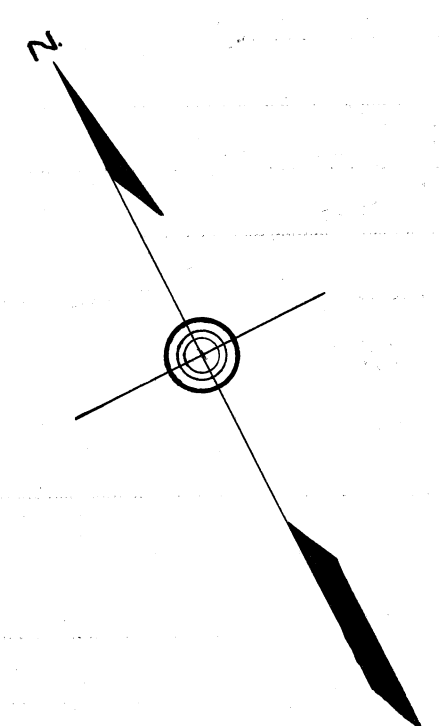

It is further ordered that a record of the proceedings and the plat and survey be entered upon the road records of this County. It is further ordered that upon the compensation and damage being paid to the owners as above herein ordered, that the public road, as shown by the surveyor's report and plat be opened up and established, and shall hereafter be a public road to be kept and maintained and improved as provided by law.

It is further ordered that a record of the proceedings and the plat and survey be entered upon the road records of this County.
