

ROAD PETITION

For the Alteration of a Road in Richland Township,
Improvement No. 74 Petitioned for by Jesse Eastham and Others.

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the

Alteration of a Public Road on the line hereinafter described; and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning

on the Public Road at the intersection of the line dividing the lands of John Lochery and Jesse Eastham; thence in a northwesterly direction over the lands of John Lochery, about one-fourth mile to a stake on the public Road leading to Stewartsville, Ohio.

The conditions of the above obligation are such, that WHEREAS, application has been made by Jesse Eastham and others to the Board of Commissioners of the said Belmont County, for the Alteration of a public road, on briefly the following line, to-wit:

THEREFORE if, 1st. The petition be not granted; or if, 2nd. The Commissioners shall order a portion of the compensation and damages to be paid by the petitioners, and the petitioners fail to pay same by the time fixed by the Commissioners: Then in either such case the said applicants will pay into the treasury of said County the COSTS AND EXPENSES incurred in the proceedings of said improvement.

They also fixed the 4th day of August 1919, at 10 o'clock A.M., as the date
 for final hearing at the office of the County Commissioners at which time it will be considered whether said improve-
 ment will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication
 once a week for three consecutive weeks in the Gazette a newspaper published and
 having a general circulation in the County of Belmont.
