

ROAD PETITION

For the Altering of a Road in Richland Township, Improvement No. 83 Petitioned for by Jesse Eastham and Others.

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the

Altering of a Public Road on the line hereinafter described; and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning at the turn of the road between the lands of Jesse Eastham and John Lochery; thence in a northwesterly direction over the lands of John Lochery; thence over the County Road to the lands of Mike Kozlovski, on the north side of the County Road; thence in a westerly direction over the lands of Mike Kovlovske, Valentine Ruvenac and James Wiley to the County Road; thence along the County Road to the lands of Mrs. Marple; thence in a westerly direction over the lands of Mrs Marple to the County Road.

Pursuant to your order dated 19, I make my report to you as follows, in the matter of the of the public road petitioned for by and others.

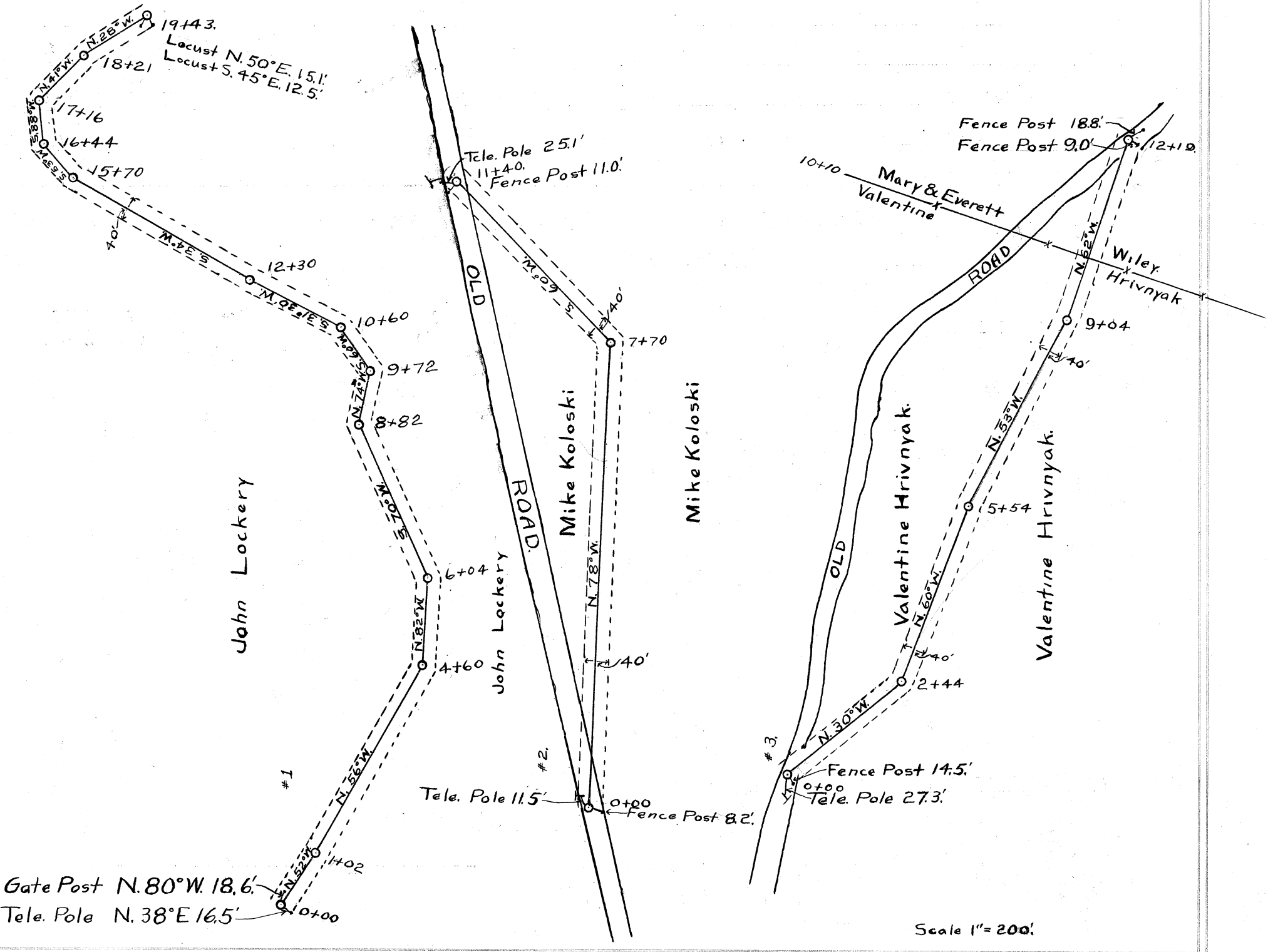
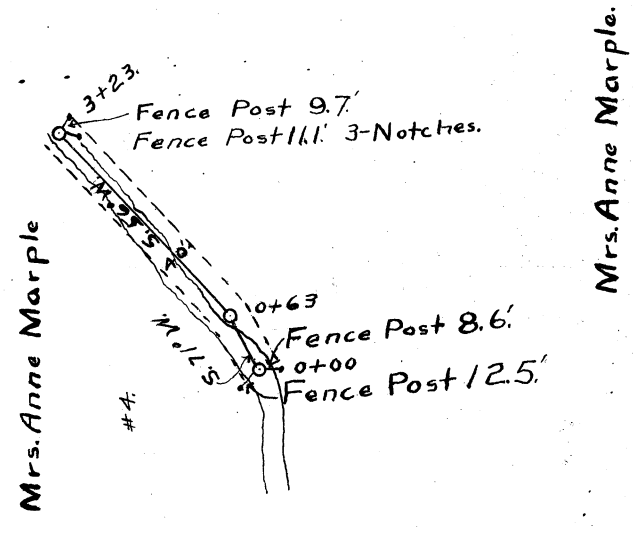
1. My opinion is the granting of the improvement; but with the following changes, which in my judgment should be made, to-wit:
