

ROAD PETITION

For the Construction of a Road in Mead and York Township, Improvement No. 94 Petitioned for by Geo. H. Brown and Others.

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the

Construction of a Public Road on the line hereinafter described; and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning on the West side of Pipe Creek at what is supposed to be a wild cherry snag near the mouth of Tumbleson run, following the North side of Tumbleson run through the lands of W. J. Berry deceased, Mrs. Isabell Creamer, and Mrs. Carrie Craig.

Crossing said run to the South side, following the South side through the lands of William Harris, John A. Giffen, Ellis D. Myres and John Kriechbaum intersecting the Pleasant Hill road on the lands of John A. Giffen.

Said County Engineer and County Commissioners shall have the right to alter said course if deemed advisable to obtain a better grade. The above petition is known as the Tumbleson run road and inter Township road of York and Mead Township.

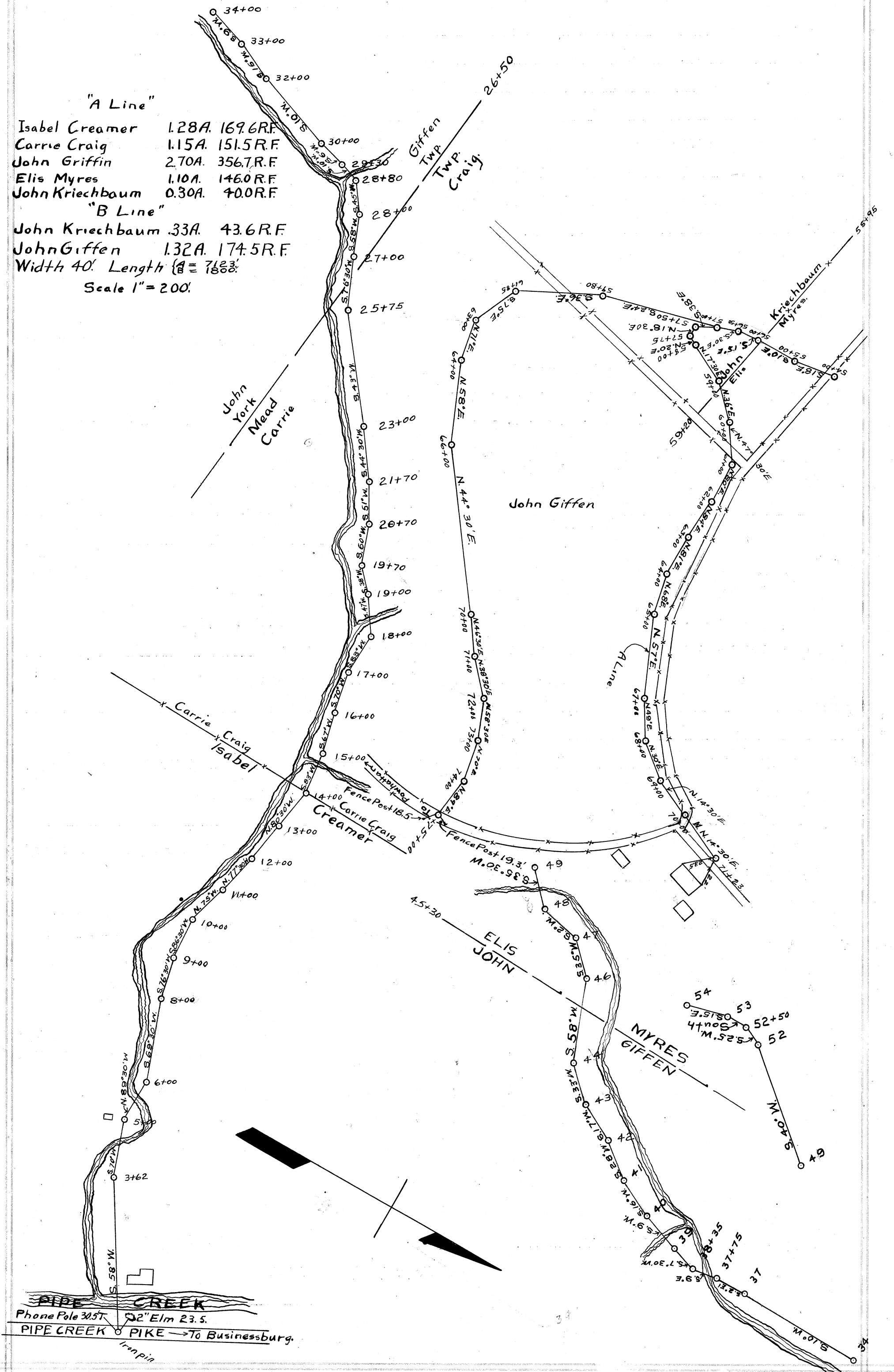
