Johnson has filed herein a bond as required by law. It is ordered that the 22nd day of June 19 20, at 10 o'clock A. M., be fixed as a date to view the same, at which date they will meet at commencing point of said proposed road and go over the route of said proposed road.

They also fixed the 12th day of July 19 20, at 1 o'clock P. M., as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the Belmont Chronicle a newspaper published and having a general circulation in the County of Belmont.

Such report shall also state the width of said improvement, which shall not be less than thirty feet nor more than sixty feet, and also recommend any changes in the improvement, which in his judgment, should be made.

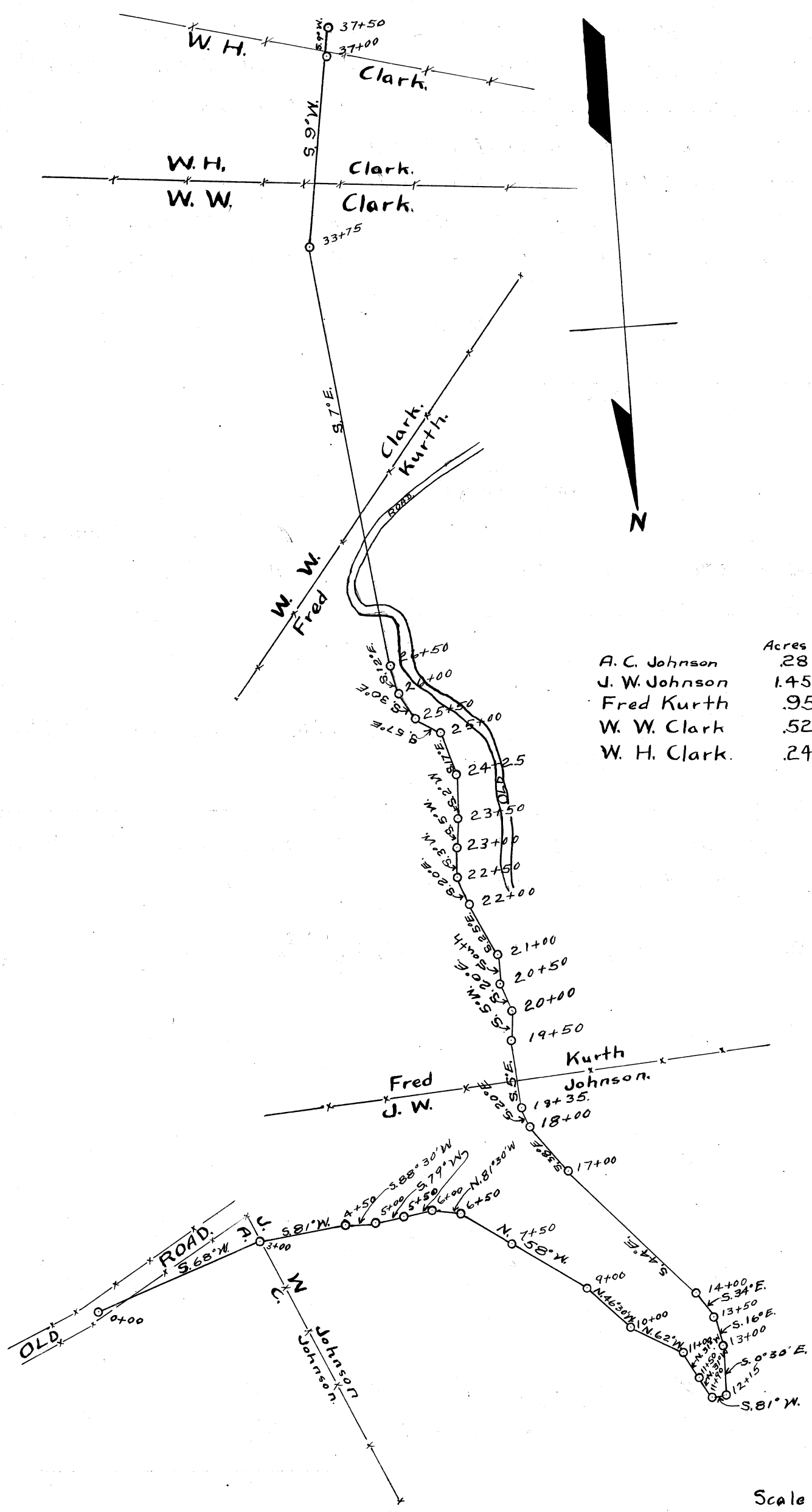
