TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the

Alteration of a Public Road on the line hereinafter described; and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning at the Belmont-Monroe County line, at or near the center of the road in the lands of A. J. Phillips, thence North over the most practical route, through the lands of A. J. Phillips, Melville and E. R. McFrederick, Harley E. Davis, Forest and Sadie Berry, Hamilton Phillips, John Seal, Ruth E. Milhoan, Samuel Hendershot, Deceased, R. R. Vanhorn, Stephen and Lossie Pittman, David Pittman, Cooper Simeral, Deceased, Jack King, and Stella Moore, Deceased, and ending in the Barnesville-Beallsville Road in the Village of New Castle, the same being between two and three miles in length.

Phillips and others, have filed a petition in the office of the Commissioners of the County, on the 1st day of June 1920, for the alteration of a

the same was this day considered by the Commissioners, and it appearing that said petition is regular and in conformity to law, and that the said A. J. Phillips has filed herein a bond as required by law. It is ordered that the 29th day of June 1920, at 10 o'clock A. M., be fixed as a date to view the same, at which date they will meet at the commencing point of said proposed road and go over the route of said proposed road.

They also fixed the 19th day of July 1920, at 1 o'clock P. M., as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the Barnesville Enterprise a newspaper published and having a general circulation in the County of Belmont.

Phillips and others, in the Barnesville Enterprise, a newspaper of general circulation in said county required by law, and the former orders of this Board, the Commissioners on this 29th day of June 19 20; met at the time and place in said notice designated and did view the route of said proposed road improvement, and considering such improvement to be of sufficient public importance, it is ordered that the County Surveyor make a plat and survey of the same and report to the Board in writing on or before the 19th day of July 19 20 the time set for the hearing, and shall set forth in said report his opinion either for or against the granting of such proposed improvement, accompanied with a statement of the estimated compensation and damages due each person, firm or corporation whose land is to be taken if the proposed improvement is established. Such report shall also state the width of said improvement, which shall not be less than thirty feet nor more than sixty feet, and also recommend any changes in the improvement, which in his judgment, should be made.

Pursuant to your order dated 19, I make my report to you as follows, in the matter of the of the public road petitioned for by and others.

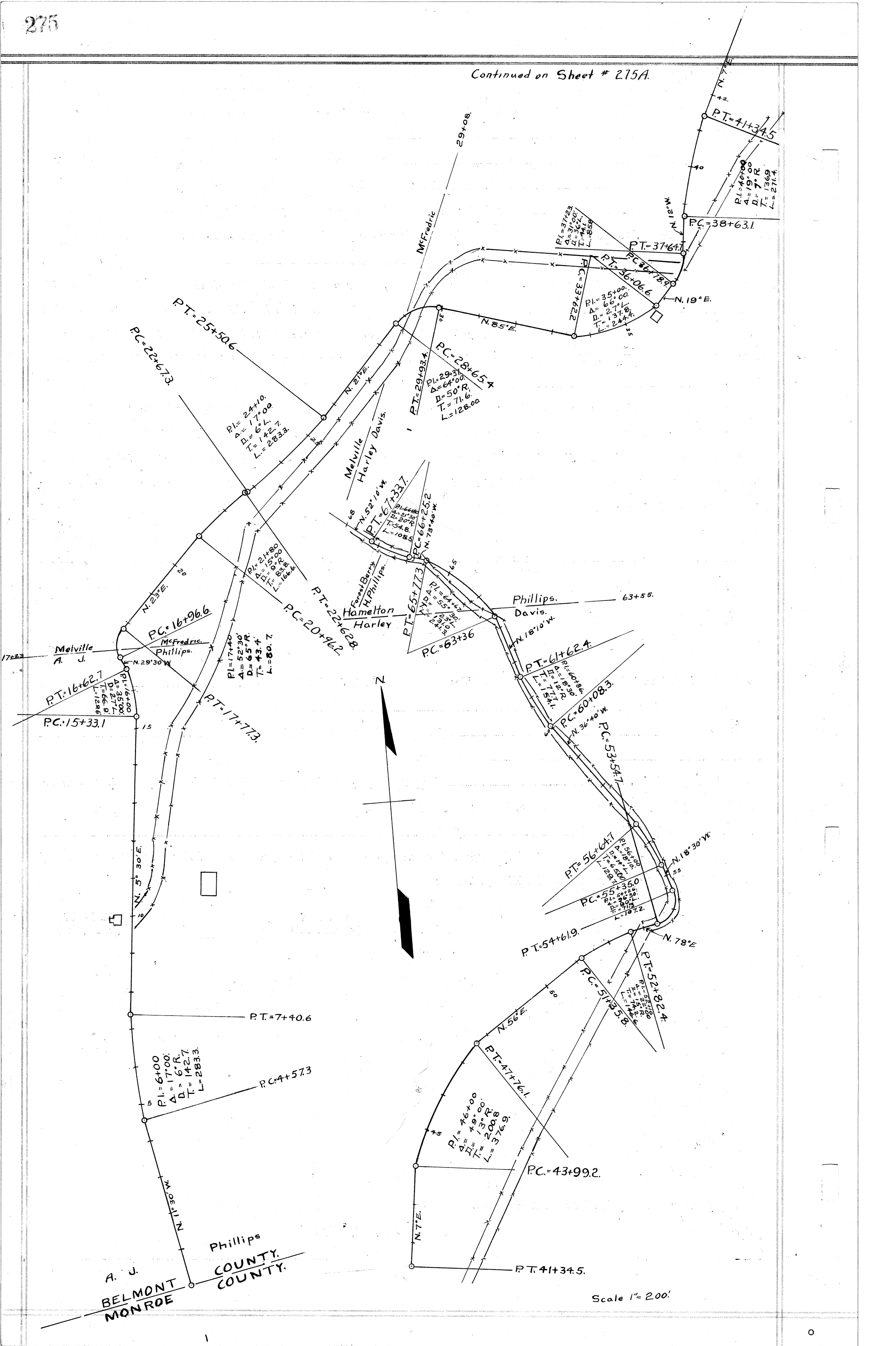
1. My opinion is the granting of the improvement; but with the following changes, which in my judgment should be made, to-wit:

3. Estimated compensation and damages, due each person, firm or corporation (with a * before the name of each minor or other person under disability), to-wit:

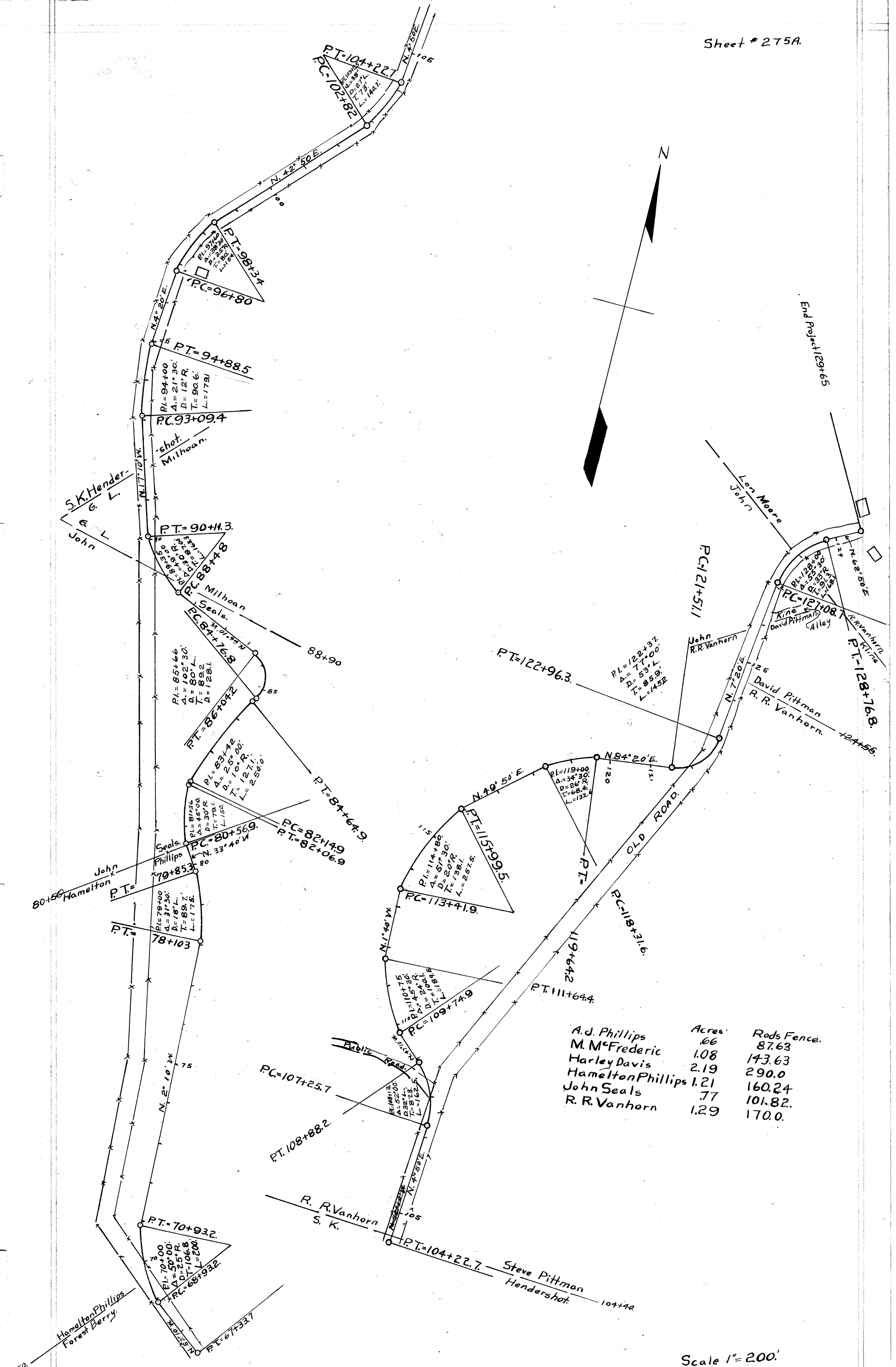

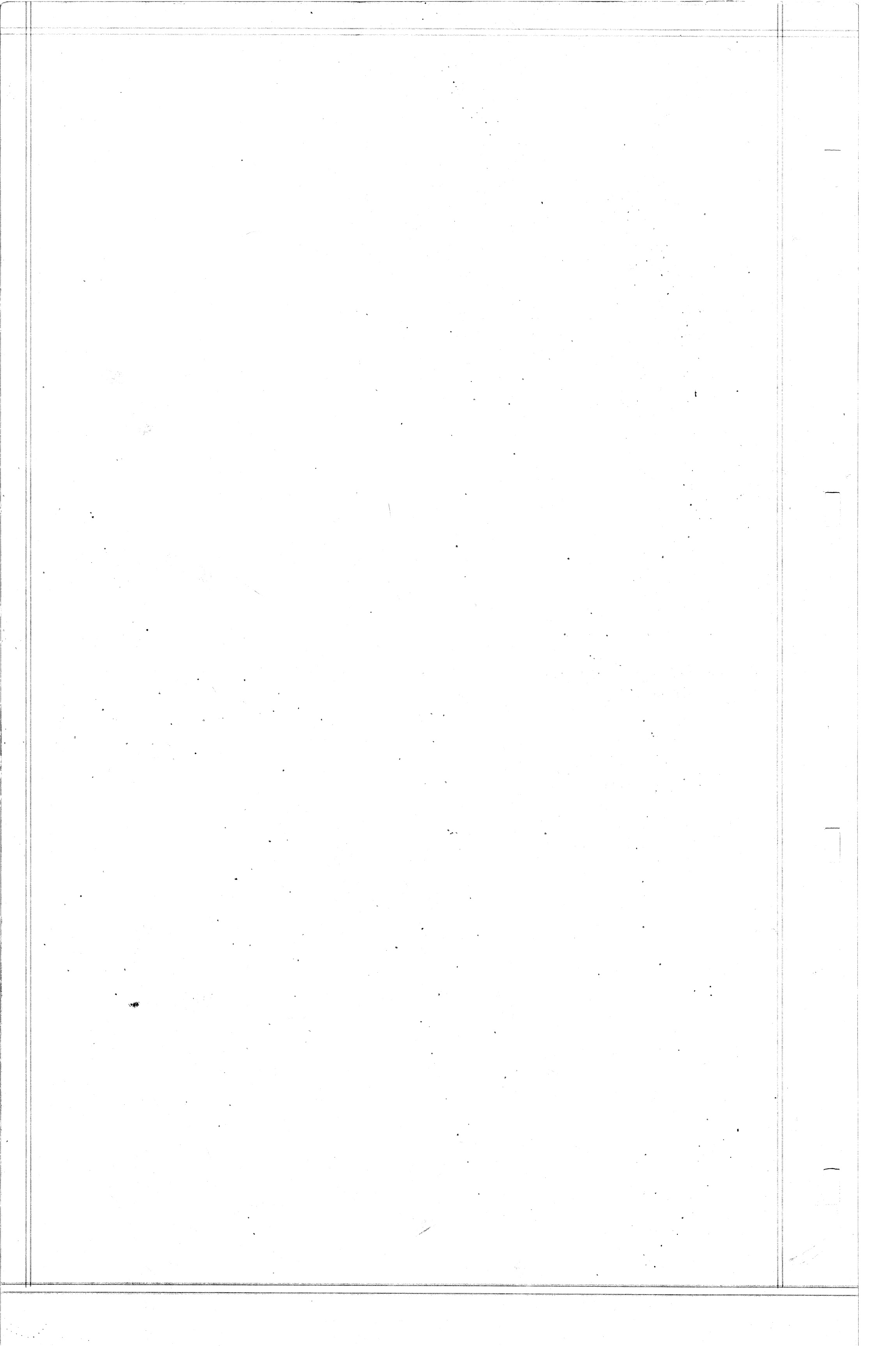

It is further ordered that a record of the proceedings and the plat and survey be entered upon the road records of this County.

be opened up and established, and shall thereafter be a public road to be kept and maintained and improved as provided by law.
