The conditions of the above obligation are such, that WHEREAS, application has been made by T. W. Brown and others to the Board of Commissioners of the said Belmont County, for the Establishing and Opening of a public road, on briefly the following line, to-wit:

THEREFORE if, 1st. The petition be not granted; or if, 2nd. The Commissioners shall order a portion of the compensation and damages to be paid by the petitioners, and the petitioners fail to pay same by the time fixed by the Commissioners: Then in either such case the said applicants will pay into the treasury of said County the COSTS AND EXPENSES incurred in the proceedings of said improvement.

the same was this day considered by the Commissioners, and it appearing that said petition is regular and in conformity to law, and that the said T. W. Brown has filed herein a bond as required by law. It is ordered that the 27th day of July 1920, at 11 o'clock A. M., be fixed as a date to view the same, at which date they will meet at the commencing point and go over the route of said proposed road.

They also fixed the 17th day of August 1920, at 1 o'clock P. M., as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the The Daily Times a newspaper published and having a general circulation in the County of Belmont.

Such report shall also state the width of said improvement, which shall not be less than thirty feet nor more than sixty feet, and also recommend any changes in the improvement, which in his judgment, should be made.
