

ROAD PETITION

For the Establishment of a Road in Wayne Township,
Improvement No. 100 Petitioned for by V. A. Martin and Others.

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the Establishment of a Public Road on the line hereinafter described; and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning at concrete bridge on lands of V. A. Martin, thence running in southerly direction on east side of creek to land of Erastus Moore, thence in same direction through said land to lands of Walton Moore, thence in same direction through said land to land of Nancy Martin, thence thru said land to land to lands of Chas. Leach, thence crossing said land bearing southwest to Creek, crossing creek to lands of J. R. Crum, thence running in same southerly direction against hill through said land to lands of Winfield Moore (Bill Smith land) thence through said land to lands of Belle Kelly, thence through said land to foot of Perkins hill at piney Creek, its place of termination.

Martin has filed herein a bond as required by law. It is ordered that the 3rd day of August 19 20, at 11 o'clock A. M., be fixed as a date to view the same, at which date they will meet at the commencing point and go over the route of said proposed road.

They also fixed the 30th day of August 1920, at 1 o'clock P. M., as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the Daily Times a newspaper published and having a general circulation in the County of Belmont.

Martin and others, due and proper notice, proof of which is on file in this office, having been given of the time and place of meeting, to view road petitioned for by V. A. Martin and others, in the Daily Times, a newspaper of general circulation in said county required by law, and the former orders of this Board, the Commissioners on this 3rd day of August 19 20, met at the time and place in said notice designated and did view the route of said proposed road improvement, and considering such improvement to be of sufficient public importance, it is ordered that the County Surveyor make a plat and survey of the same and report to the Board in writing on or before the 30th day of August 19 20, the time set for the hearing, and shall set forth in said report his opinion either for or against the granting of such proposed improvement, accompanied with a statement of the estimated compensation and damages due each person, firm or corporation whose land is to be taken if the proposed improvement is established. Such report shall also state the width of said improvement, which shall not be less than thirty feet nor more than sixty feet, and also recommend any changes in the improvement, which in his judgment, should be made.
