For the Alteration of a Road in Colerain Township,  
Improvement No. 101 Petitioned for by R. M. Simpson and Others.

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

*The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the*

*Alteration of a Public Road on the line hereinafter described; and pray that you will institute and order the*

*proper proceedings for said improvement, to-wit: Beginning Known as the Barton Road leading from Barton*

*to the Creseent-St. Clair sville Road; Beginning for such alteration at a point therein at the north east corner of the land of The Barton Coal Company and near to the stone dump of said company; thence in a southeasterly direction over the land of The Barton Coal Company to the track of The Baltimore and Ohio Railroad Company; thence crossing the track of the Baltimore and Ohio Railroad Company in an easterly direction over land of the Youghiogheny and Ohio Coal Company to the land formerly owned by Obed Hardesty; thence in an easterly direction over the land of The Belmont Land Company to the road leading from St. Clairsville to Barton, at a point therein near The Greek Catholic Church.*

Simpson and others, have filed a petition in the office of the Commissioners of the County, on the 12th day of July 19 20, for the alteration of a

the same was this day considered by the Commissioners, and it appearing that said petition is regular and in conformity to law, and that the said R. M. Simpson has filed herein a bond as required by law. It is ordered that the 26th day of July 19 20, at 3 o'clock P. M., be fixed as a date to view the same, at which date they will meet at the commencing point and go over the route of said proposed road.

They also fixed the 16th day of August 19 20, at 1 o'clock P. M., as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the Daily Times a newspaper published and having a general circulation in the County of Belmont.

Simpson and others, due and proper notice, proof of which is on file in this office, having been given of the time and place of meeting, to view road petitioned for by R. M. Simpson and others, in the Daily Times, a newspaper of general circulation in said county required by law, and the former orders of this Board, the Commissioners on this 26th day of July 19 20, met at the time and place in said notice designated and did view the route of said proposed road improvement, and considering such improvement to be of sufficient public importance, it is ordered that the County Surveyor make a plat and survey of the same and report to the Board in writing on or before the 16th day of August 19 20 the time set for the hearing, and shall set forth in said report his opinion either for or against the granting of such proposed improvement, accompanied with a statement of the estimated compensation and damages due each person, firm or corporation whose land is to be taken if the proposed improvement is established. Such report shall also state the width of said improvement, which shall not be less than thirty feet nor more than sixty feet, and also recommend any changes in the improvement, which in his judgment, should be made.

Pursuant to your order dated 19, I make my report to you as follows, in the matter of the of the public road petitioned for by and others.

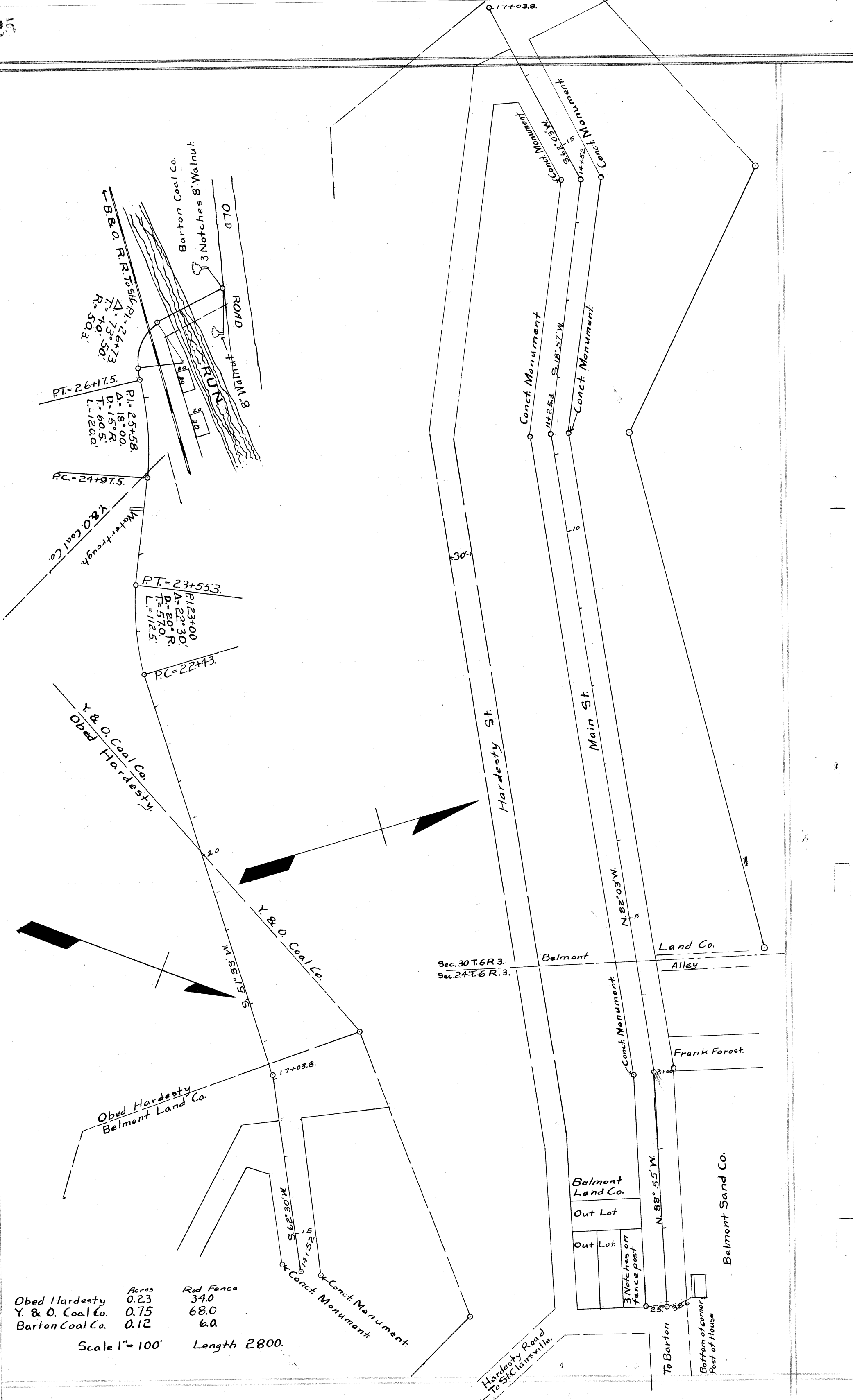
1. My opinion is the granting of the improvement; but with the following changes, which in my judgment should be made, to-wit:
