

ROAD PETITION

For the Vacation of a Road in Flushing Township, Improvement No. 105 Petitioned for by C.C. Williams and Others.

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the

Vacation of a Public Road on the line hereinafter described; and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning at residence at Claude Williams' Farm in Flushing Township, Belmont County, Ohio, and extending northeast about sixty rods to a point near the northeast corner of the Claude Williams' farm; thence beginning at the corner stone between Ann Brown and Henry Fox in Said Township and County and State and extending northeast about 150 rods to the Ridge Road. Said road to be vacated being in two sections of what was formerly known as the Long Point Road, in Flushing Township, Belmont County, Ohio.

The Claude Williams Farm being the farm on which he now resides.

THEREFORE if, 1st. The petition be not granted; or if, 2nd. The Commissioners shall order a portion of the compensation and damages to be paid by the petitioners, and the petitioners fail to pay same by the time fixed by the Commissioners: Then in either such case the said applicants will pay into the treasury of said County the COSTS AND EXPENSES incurred in the proceedings of said improvement.

the same was this day considered by the Commissioners, and it appearing that said petition is regular and in conformity to law, and that the said C. C. Williams has filed herein a bond as required by law. It is ordered that the 14th day of September 1920, at 10 o'clock A. M., be fixed as a date to view the same, at which date they will meet at the commencing point and go over the route of said proposed road.

They also fixed the 27th day of September 1920, at 1 o'clock P.M., as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the Belmont Chronicle a newspaper published and having a general circulation in the County of Belmont.

Williams and others, due and proper notice, proof of which is on file in this office, having been given of the time and place of meeting, to view road petitioned for by C. C. Williams and others, in the Belmont Chronicle, a newspaper of general circulation in said county required by law, and the former orders of this Board, the Commissioners on this 14th day of September 19 20, met at the time and place in said notice designated and did view the route of said proposed road improvement, and considering such improvement to be of sufficient public importance, it is ordered that the County Surveyor make a plat and survey of the same and report to the Board in writing on or before the 27th day of September 19 20 the time set for the hearing, and shall set forth in said report his opinion either for or against the granting of such proposed improvement, accompanied with a statement of the estimated compensation and damages due each person, firm or corporation whose land is to be taken if the proposed improvement is established. Such report shall also state the width of said improvement, which shall not be less than thirty feet nor more than sixty feet, and also recommend any changes in the improvement, which in his judgment, should be made.

Pursuant to your order dated 19, I make my report to you as follows, in the matter of the of the public road petitioned for by and others.

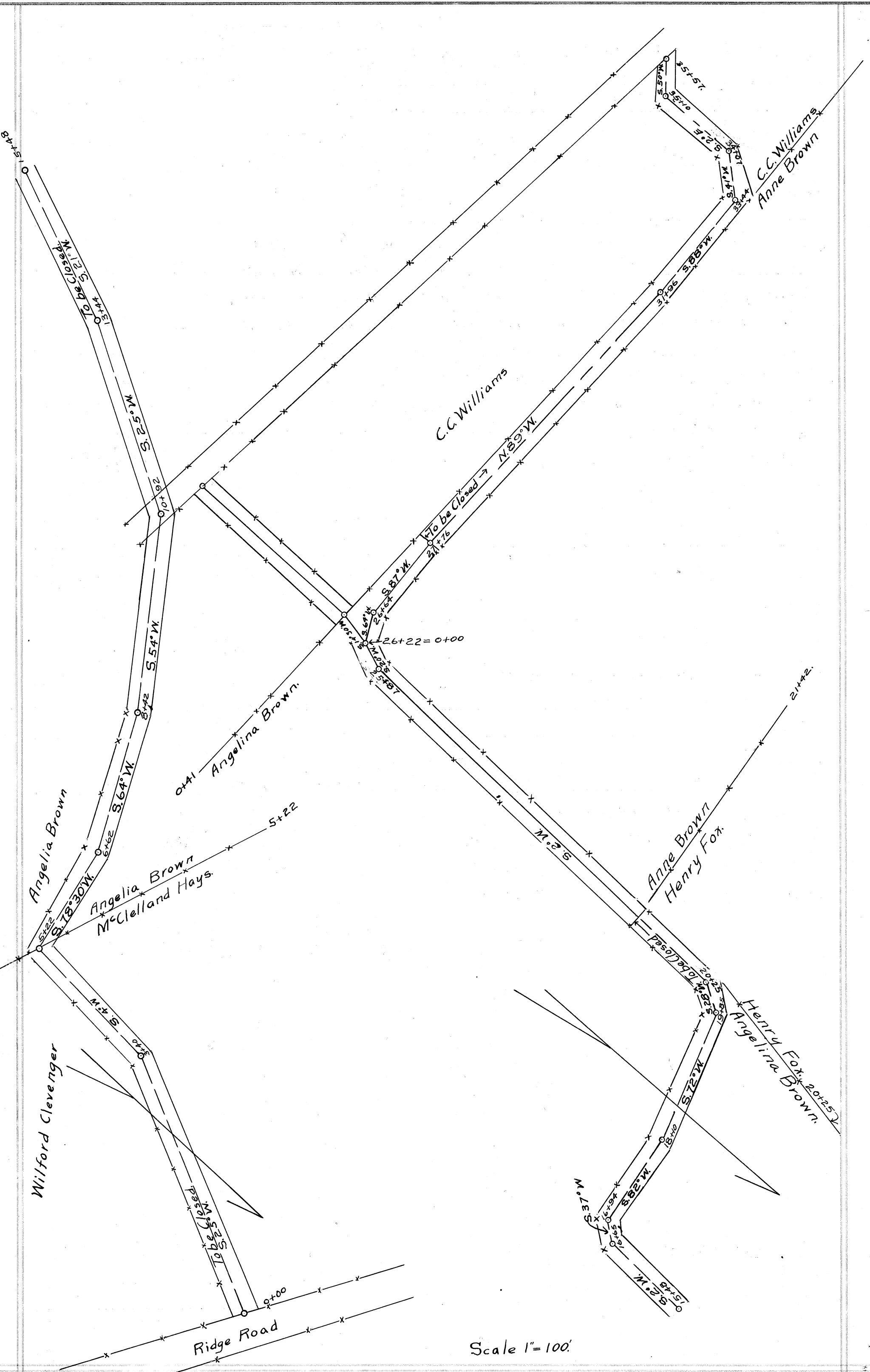
1. My opinion is the granting of the improvement; but with the following changes, which in my judgment should be made, to-wit:
