For the Changeing of a Road in Smith Township,
 Improvement No. 112 Petitioned for by A. N. Delaney and Others.

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the

of a Public Road on the line hereinafter described; and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning At the run Crossing at H. H. Aults Changeing the run to the south side of the road through the lands of D. E. & A. V. Diday & H. H. Ault also through the lands of Ida Riffer & Edward West thus doing away with the 3 run crossings and One bridge, then going to the foot to the hill near the line of J. W. Jackson and changeing to the most suitable place for a better grade through the lands of Ida Riffer and ending near the line of H. E. Piper.

Delaney and others, have filed a petition in the office of the Commissioners of the County, on the 11th day of April 19 21, for the changing of a public road, along the following route, to-wit: Beginning

the same was this day considered by the Commissioners, and it appearing that said petition is regular and in conformity to law, and that the said A. N. Delaney has filed herein a bond as required by law. It is ordered that the 19th day of May 19 21, at 10 o'clock A.M., be fixed as a date to view the same, at which date they will meet at the commencing point and go over the route of said proposed road.

They also fixed the 23rd day of May 19 21, at 1:30 o'clock P.M., as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the Belmont Chronicle a newspaper published and having a general circulation in the County of Belmont.

Delaney and others, due and proper notice, proof of which is on file in this office, having been given of the time and place of meeting, to view road petitioned for by A. N. Delaney and others, in the Belmont Chronicle, a newspaper of general circulation in said county required by law, and the former orders of this Board, the Commissioners on this 17th day of May 19 21, met at the time and place in said notice designated and did view the route of said proposed road improvement, and considering such improvement to be of sufficient public importance, it is ordered that the County Surveyor make a plat and survey of the same and report to the Board in writing on or before the 20th day of June 19 21, the time set for the hearing, and shall set forth in said report his opinion either for or against the granting of such proposed improvement, accompanied with a statement of the estimated compensation and damages due each person, firm or corporation whose land is to be taken if the proposed improvement is established. Pursuant to your order dated 19, I make my report to you as follows, in the matter of the of the public road petitioned for by and others.

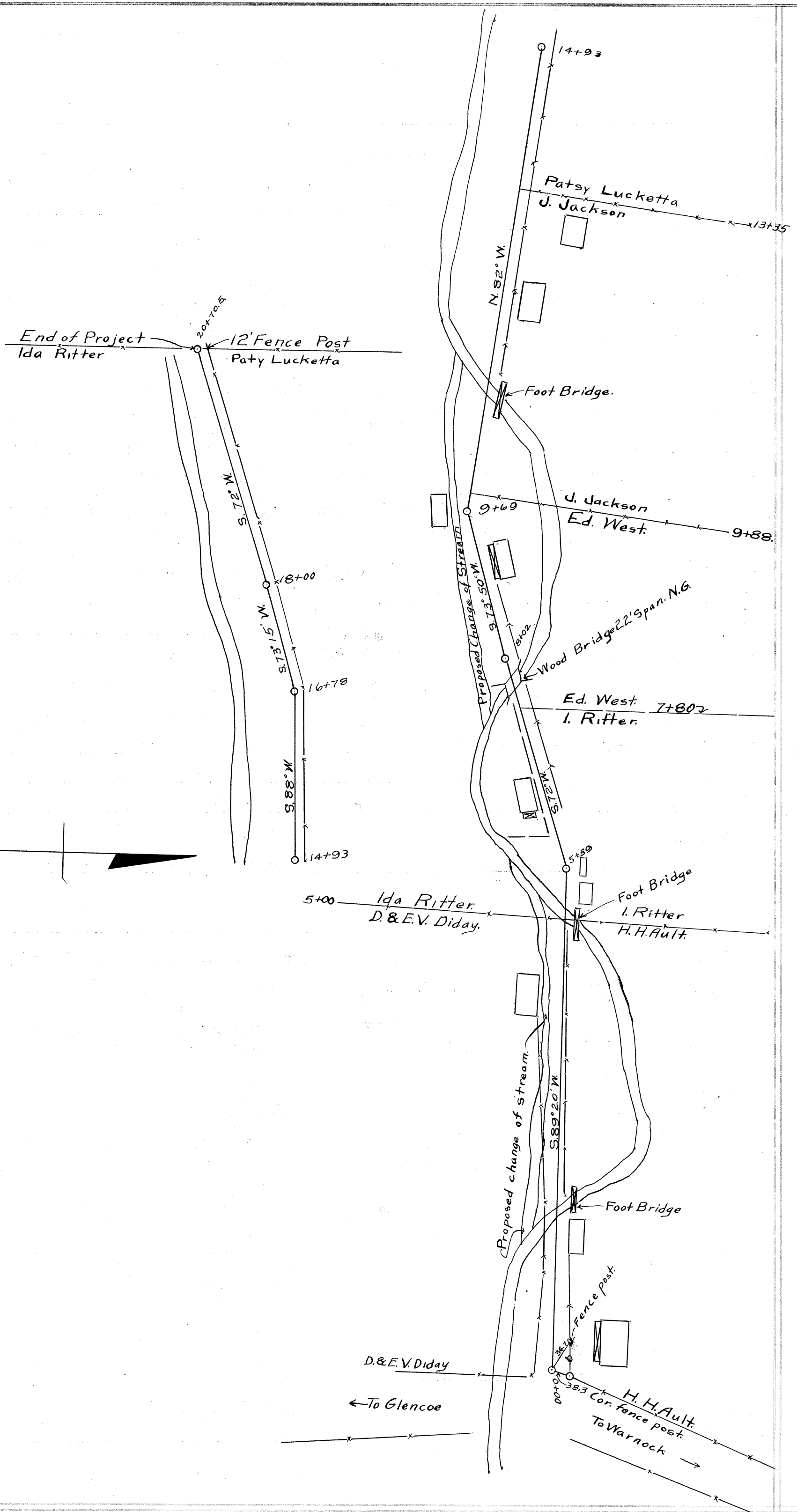
1. My opinion is the granting of the improvement; but with the following changes, which in my judgment should be made, to-wit:

The Commissioners further find and are of the opinion that said improvement is of sufficient importance to the public for all of the Compensation and Damages to be paid from the County Treasury.

And it is ordered that the auditor draw his warrant on the County Treasury in favor of the claimant above named for the amounts awarded them respectively as aforesaid.

It is further ordered that a record of the proceedings and the plat and survey be entered upon the road records of this County.

It is further ordered that upon the compensation and award being paid to the owners as above herein ordered, that the public road described as follows: as described and designated on the plat herein

be opened up and established, and shall thereafter be a public road to be kept and maintained and improved as provided by law.
