

### ROAD PETITION

For the vacation of a Road in Richland Township,  
Improvement No. 119 Petitioned for by F. A. Magee and Others.

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

*The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the vacation of a Public Road on the line hereinafter described; and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning at the intersection of the E. M. Neff road with the old St. Clairsville-Barnesville Road and thence following the old St. Clairsville-Barnesville Road west to the junction of the Carman Road with the old St. Clairsville-Barnesville Road. Said road being located in Richland Township, Belmont County, Ohio.*

F. A. Magee and others to the Board of Commissioners of the said Bel-

compensation and damages to be paid by the petitioners, and the petitioners fail to pay same by the time fixed by the

AND EXPENSES incurred in the proceedings of said improvement.

the same was this day considered by the Commissioners, and it appearing that said petition is regular and in conformity to law, and that the said F. A. Magee has filed herein a bond as required by law. It is ordered that the 13th day of December 19 21, at 10 o'clock A. M., be fixed as a date to view the same, at which date they will meet at the commencing point and go over the route of said proposed road.

They also fixed the 3rd day of January 19 22, at 1 o'clock P. M., as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the St. Clairsville Gazette a newspaper published and having a general circulation in the County of Belmont.

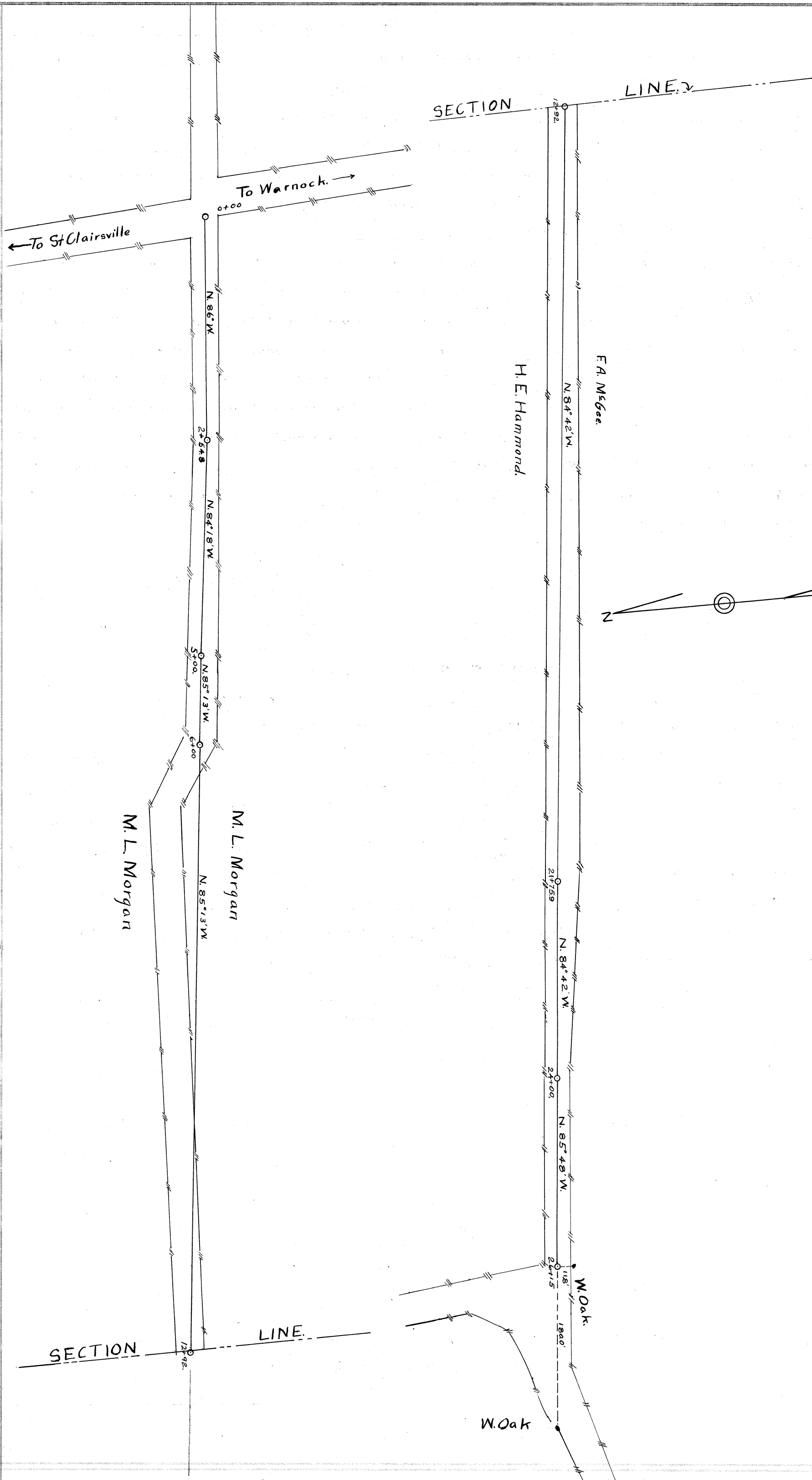
