

ROAD PETITION

For the Altering and changing of a Road in Somerset Township,
 Improvement No. 203 Petitioned for by W. T. Lyne and Others
 TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the altering and changing of a Public Road on the line hereinafter described and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning

Near the N. E. corner of the T. C. McCort farm, on F. L. Carpenter road going south, altering and changing, left turn in road.

Near gate or entrance to field, on W. side of F. L. Carpenter road and S. E. of woods, on Geo. Butler farm, going south, altering or changing, steep bank.

Near entrance to C. W. Wheatley's residence, on F. L. Carpenter road, going south, altering or changing road, through A. B. Davis farm (crossing T. W. V. & O. R. R. survey at "Indian Low Hollow") and continuing in a southern direction, on F. L. Carpenter road, altering or changing road through farms of Sallie Johnson and Robert Roe, ending near Chestnut tree at S. E. corner of Robt. Roe farm.

Lyne has filed herein a bond as required by law. It is ordered that the 10th day of May 1927, at 10.00 o'clock A. M., be fixed as a date to view the same, at which date they will meet at the commencing point and go over the route of said proposed road.

They also fixed the 23rd day of May 1927, at 10.00 o'clock A. M., as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the Barnesville Whetstone a newspaper published and having a general circulation in the County of Belmont.

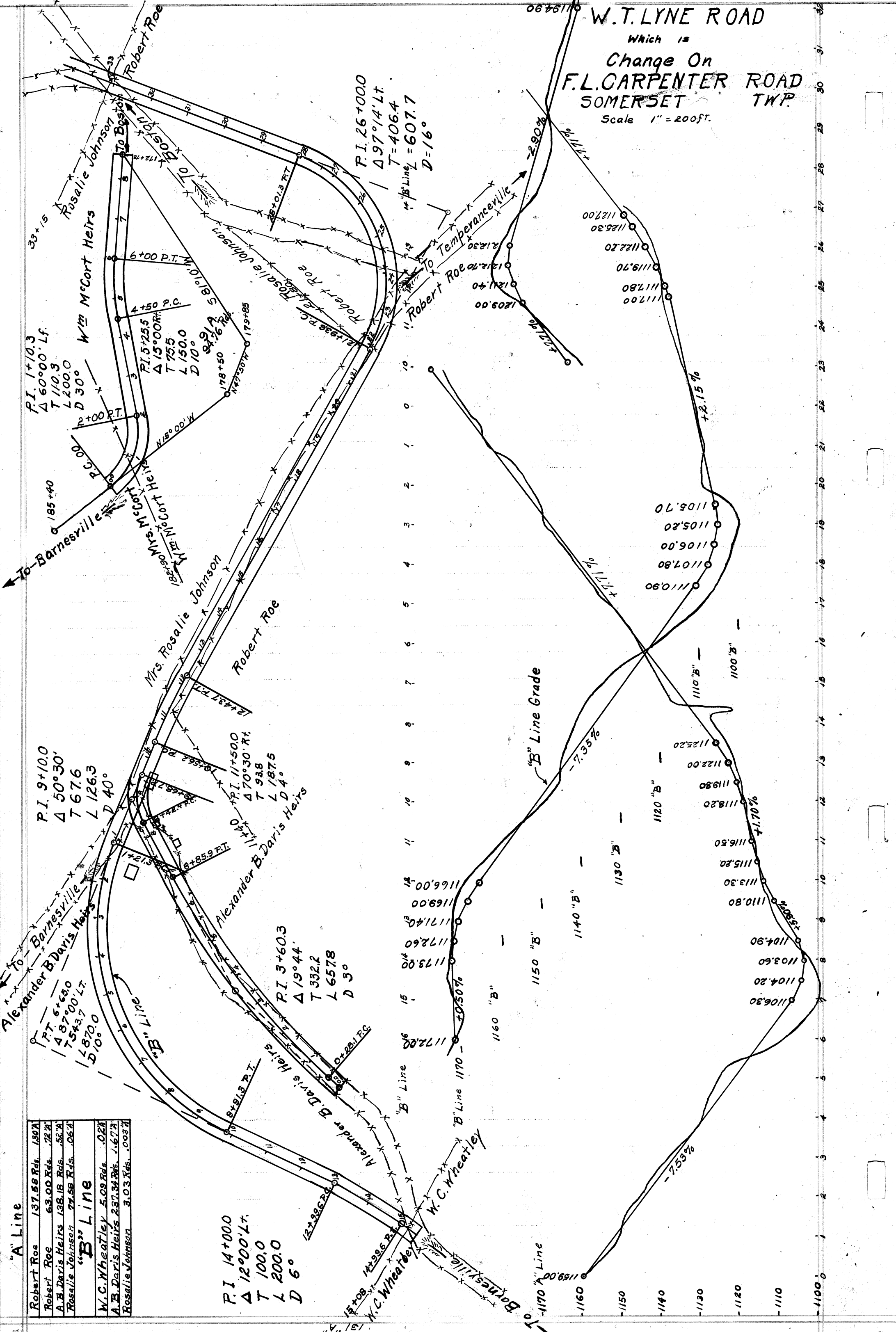
