

ROAD PETITION

For the vacation of a Road in Wayne Township,
Improvement No. 213 Petitioned for by Annie E. Carpenter and Others
TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the vacation of a Public Road on the line hereinafter described and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning
Near the residence of Mary E. Carpenter extending southeast thru and along lands owned by Mary E. Carpenter, Matilda Craig, Anne E. Carpenter, Eugene Benedict and Jno. F. Truex to the line of Jno. F. Truex. This road being known as Long Run Road.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the Belmont Chronicle a newspaper published and having a general circulation in the County of Belmont.

Such report shall also state the width of said improvement, which shall not be less than thirty feet nor more than sixty feet, and also recommend any changes in the improvement, which in his judgment, should be made.
