

ROAD PETITION

For the vacation of a Road in Mead Township,
 Improvement No. 256 Petitioned for by G. C. Brooking and Others
 TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the vacation of a Public Road on the line hereinafter described and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning
 At a point in the center of the Pipe Creek Road, from which two tacks in a telephone pole bears N. 88°-56'E.-66.2' distant and from which tow tacks in a locust tree bears N. 67°-56'W-30.2' distant, thence S. 9°-45'E.-105.5' to a stake in the center of said road to be vacated, from which stake the center face of north abutment of old bridge over Pipe Creek bears S. 48°E.-15.5' distant thence from said stake S. 48°E.-527.8' to a stake (formerly an iron pin) in the center of said road; thence S. 55°E.-406' plus or minus to the low water mark of the Ohio River.

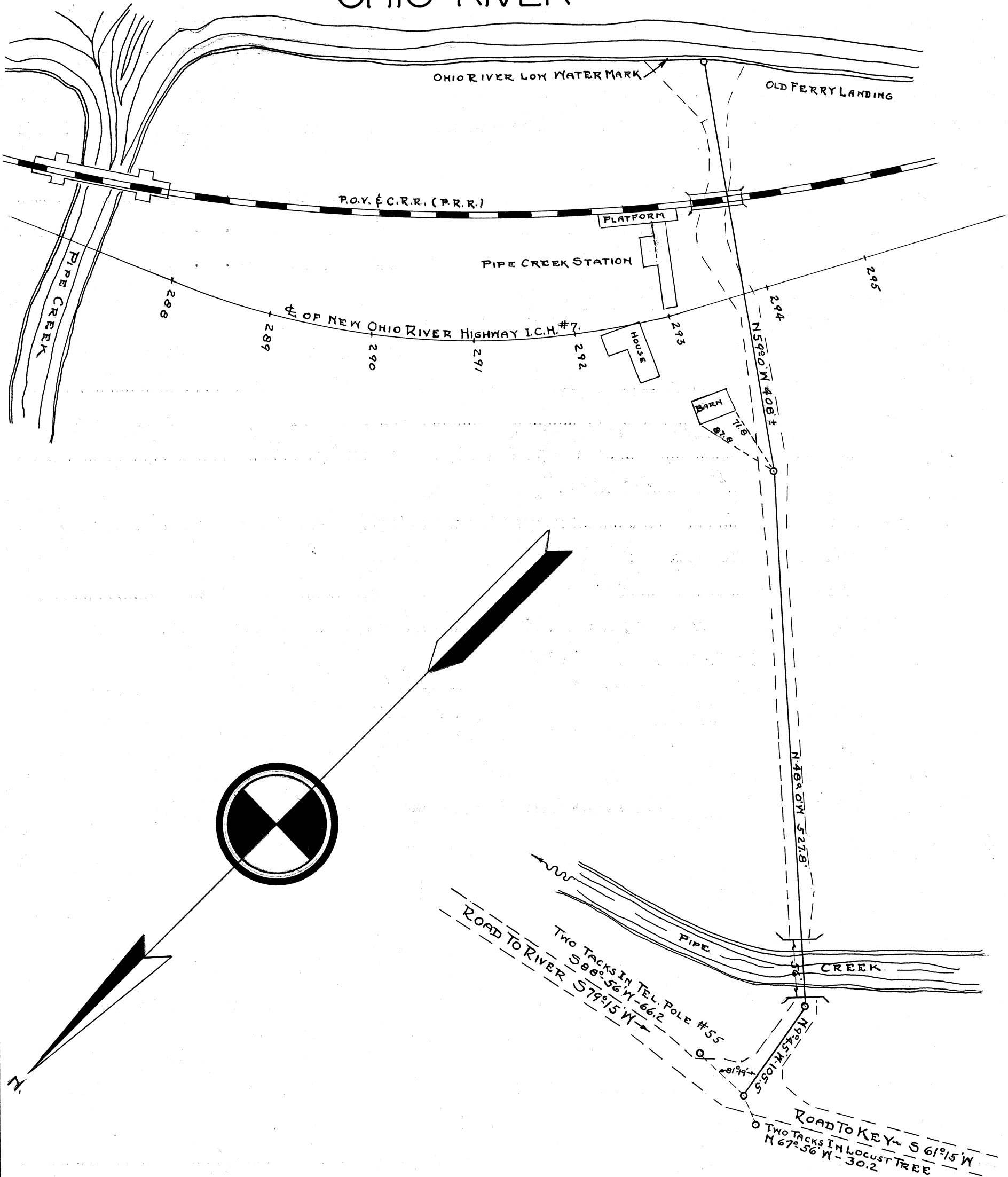
