

ROAD PETITION

For the improvement of a Road in Wheeling Township,
Improvement No. 270 Petitioned for by George Klamut and Others
TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the improvement
.....of a Public Road on the line hereinafter described and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning
At the end of an old Township Pike near Thos. Pollock's barn on the Fairpoint-Shepherdstown road in Section 13 Wheeling Township, thence with said road thru the lands of Thos. Pollock, Jehn Watson, J. P. Ferguson and H. A. Love, a distance of about one mile; thence turning to the right thru the land of J. Dunn and Thos. Love all in Section 14; thence in Section 8 thru lands of Martha Coleman, Andy Droskey, L. and M. Dunn, J. & M. Luskasko, thence turn to right to S. A. Myers and heirs of Joseph Moore's; thence thru Pete Mozden's farm, thru village of Kinsman and Kinsman School, thru Walter Coleman's farm to Blainesville, connecting with Maynard Pike, a distance of about 4 $\frac{1}{2}$ miles following the old road as near as practical.
