

ROAD PETITION

For the alteration of a Road in Colerain Township, Improvement No. 274 Petitioned for by Jemima W. Boggs and Others TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the alteration of a Public Road on the line hereinafter described and pray that you will institute and

order the proper proceedings for said improvement, to-wit: Beginning

At a point on State Route No. 250 about one mile east of the unincorporated village of Pleasant Grove, and running in an easterly direction and connecting with the improved road running between Martins Ferry and Mt. Pleasant, Ohio, at a point about one mile southwest of the line between Jefferson and Belmont Counties, in said road.

The portion of said route hereby petitioned to be located and established upon a new location, being described as follows, to-wit:

Beginning at a point on said road on the east line of lands owned by Clara and Katherine Major and continuing in an easterly direction to a point near the east line of the lands owned by the Y. and O. Coal Co., being about one mile, more or less, in length, and being all that portion of said road lying in and along a certain ravine, and which portion of said road has been destroyed by floods and derosion.
