

ROAD PETITION

For the alteration of a Road in Somerset Township,
 Improvement No. 322 Petitioned for by C. C. Chappell and Others
 TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the alteration of a Public Road on the line hereinafter described and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning
 At or near the culvert at the foot of the hill and to continue as the County Surveyor may deem best to give a good grade to point near a certain locust tree at the top of said hill. The proposed change would be a distance of about 1/3 of a mile in all.

They also fixed the 15th day of June 1931, at 10.00 o'clock A.M., as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the Barnesville Enterprise a newspaper published and having a general circulation in the County of Belmont.

Such report shall also state the width of said improvement, which shall not be less than thirty feet nor more than sixty feet, and also recommend any changes in the improvement, which in his judgment, should be made.

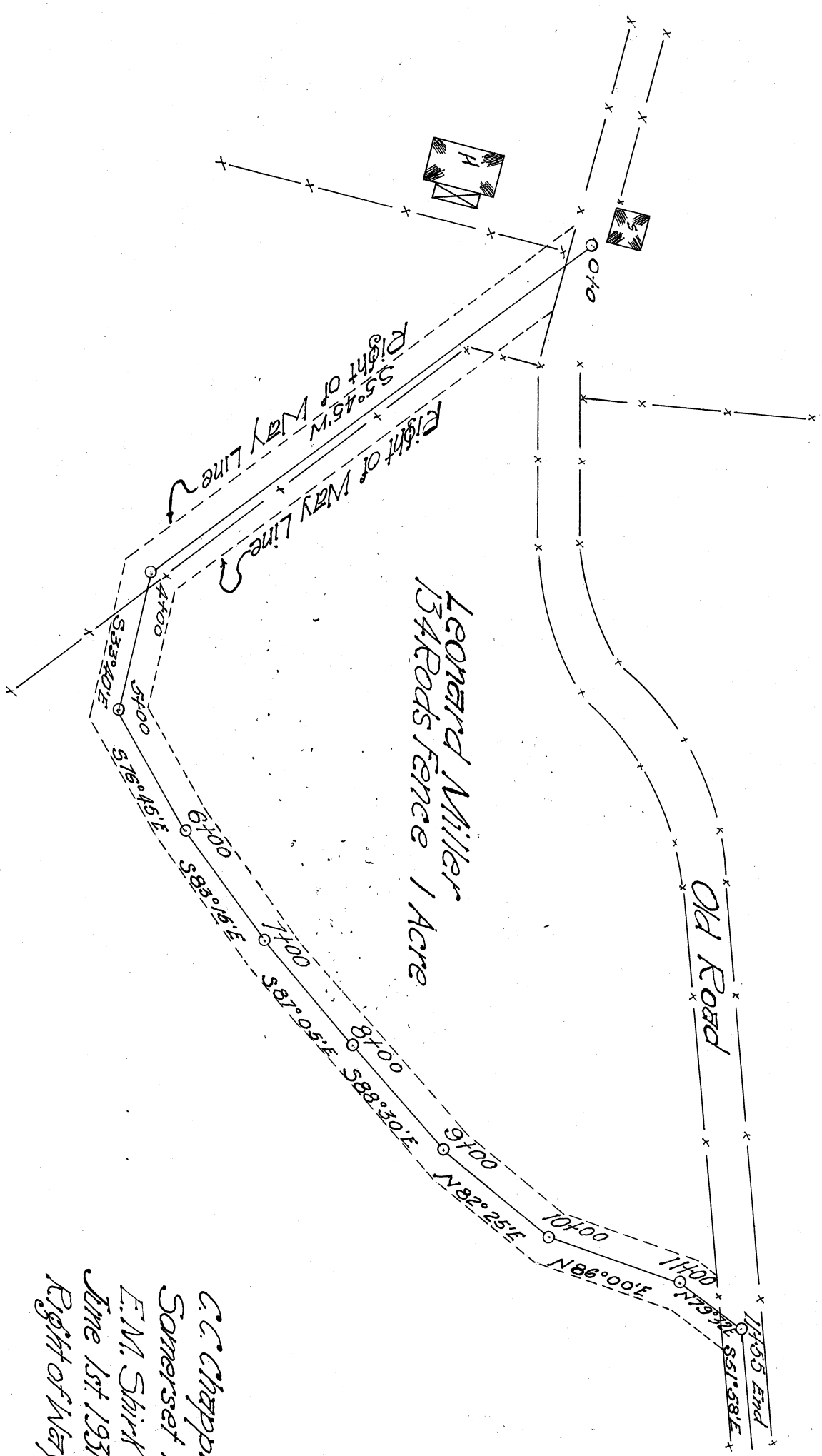
