The description of the centerline herewith described is only approximate and it is to be understood that the County Engineer will make at a letter date and accurate survey and plat of Gaid Road and a dedication on said plat will be signed by us.

Beginning at a point in the center line of a township Road at the Lane leading to the charles M. Inherst residence, said point of beginning is 1200' North and 600' east of the S.W.
