Provided the trustees of Smith & Mead Township agree to pay for the inprovement , If however the township Trustee, s




the property owner vitally intrested, reqests that for the present the road be inproved only to his dwelling

which is a distance of .614 miles. The Approximate cost of said .614 Miles exclusive of paving is \$1000.




