ROAD PETITION

For the *Vacation of a part* of a Road in *Twp. Griffith Rd, Wheeling* Township,

Improvement No. *570 - C* Petitioned for by *The Pittsburgh Consolidation Coal Co. and Others*

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the *Vacation*

..... of a Public Road on the line hereinafter described and pray that you will institute and order

the proper proceedings for said improvement, to-wit: Beginning *at a point at an intersection of Township Roads, said westerly terminus of Township Road herein petitioned to be vacated, said point being located in the Northwest quarter of Section 26, Wheeling Township, Twp. 8, Range 4, Belmont County, Ohio, about 2444 feet south of the north boundary of Section 26 and about 1376 feet east of the western boundary of Section 26; thence in a southeasterly and easterly direction 1386 feet more or less; thence easterly and northeasterly 1010 feet more or less to the south side of bridge over Campbell Run, the eastern terminus of Township Road herein petitioned to be vacated, said point is referenced as follows; From the southwest corner of the northeast quarter of Section 26 (also is the center of Section 26) N. 2°-22'-30" E. 633.93 feet along the West boundary of the northeast quarter of Section 26; thence at right angles to the West boundary of the northeast quarter of Section 26, S. 87°-37'-30" E. 756.38 feet to the eastern terminus point. All of the foregoing described Township Road is in Section 26, the total length of which is 2396 feet more or less.*

They also fixed the 11th day of March 1953, at 11:00 o'clock A.M., as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the St. Clairsville Gazette a newspaper published and having a general circulation in the County of Belmont.

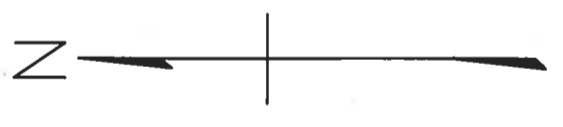
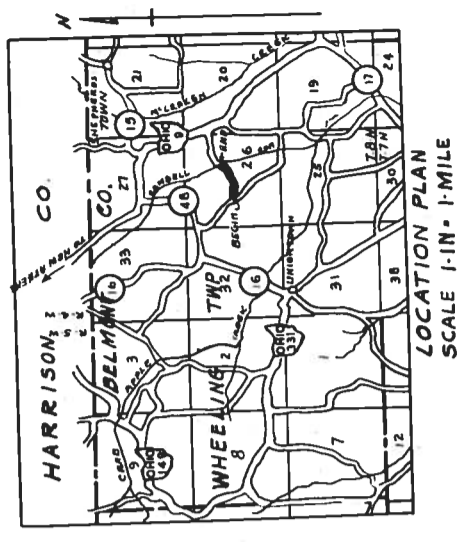
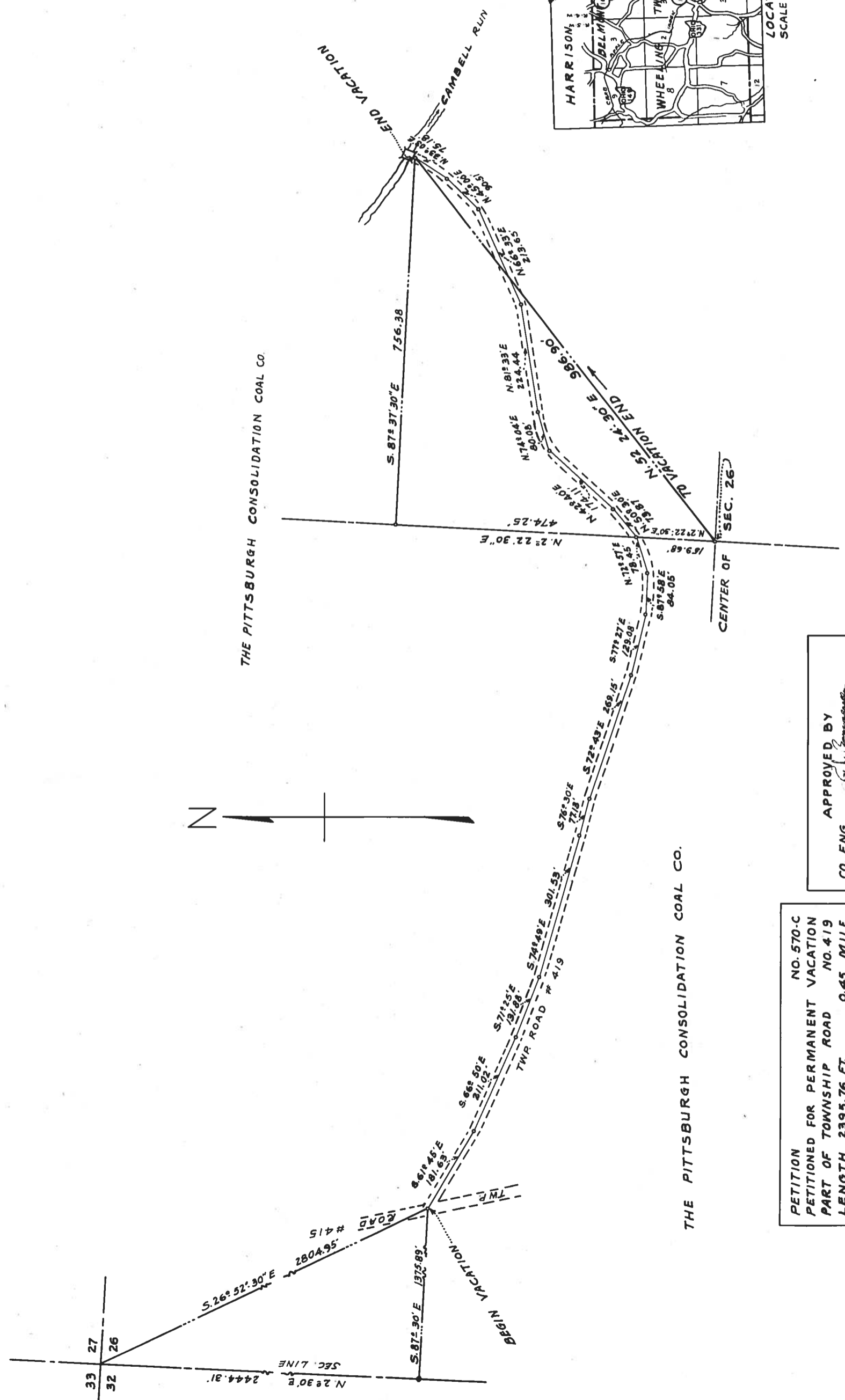
