

For the Relocation & Vacation of a Road in Washington Improvement No. 583 Petitioned for by Emory Walters

TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the Vacation Releation of a Public Road on the line hereinafter described and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning at about & mile from where the Walters road joins Clover Ridge, approximately 3 mile should be relocated. This portion is very hard to maintain because it runs parallel to hillside and catches much water. There are three landslides which settle or slide out every winter.

By relocating upon ridge, - it would eliminate turns, shorten the distance, and be Cheaper to maintain, thus being a saving, rather than an expense to taxpayer.

This road is a mail and a school Bus route, Leads to Cats Run Mine Entrance and is a short route to Powhatan from Clover Ridge.

Freeholders of property through which the road passes are H. H. Walters, E.C. Walter and Mrs. Bessie Schnegg.

We desire that the old portion of above mentioned road be vacated, to wit, that portion of the present road replaced by the relocation thereof, if this petition be granted.

The portion of said road herein petitioned to be relocated and vacated is known as the Walters Township Road, situated in Washington Township, Belmont County, Ohio.






