For the Vacation of a Part (Tup. Road) of a Road in Wheeling Township,
Improvement No. 596 Petitioned for by The Pitts burgh Consolidation Coal Co. 19 and Others
TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the Vacation of a Public Road on the line hereinafter described and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning at a point in the Center of Township Road No. 421 (commonly called Metro Road), said point being in

the West boundary of Section 15, about 140 feet from the Southwest Corner thereof; Thence in a general Easterly direction 1425 ft. More or less to the intersection of Township Road No. 421 with County Road No. 62 leading from Village of Shepherdstown to Village of Fairpoint, the terminus of petitioned vacation being 0.27 miles More or less in length.

The Soregoing described road being located in Section 15, Wheeling Township (T.8) Range 4, Belmont County, Ohio, and is a portion of Township Road No. 421 known as Metro Road. Petitioners allege that such Road serves no useful purpose to the traveling public




