

Mr. Dorsey moved the adoption of the following Resolution:

WHEREAS, This Board of County Commissioners is of the opinion that it will be for the public convenience or welfare to vacate a portion of County Highway 42, a Public Road on the line hereinafter described, known as the Fulton Hill Road; the same not being a road on the State Highway System.

The following is the general route and termini of said Rod:

Beginning at a point in the Fulton Hill Road in the lands of Cowen & Waddell Trustees which point bears approx. northeast 340 feet from the southeast corner of Pultney Township Sec. 35, Township 2, Range 2; thence following said raod in a southwesterly direction through the lands of Cowen & Waddell Trustees about 365 feet to the section line between Sec. 35, Township 2, Range 2 and Sec. 5, Township 5, Range 3; thence through the lands of Ful-Brook Land Development Co. in a southwest and northwest direction about 1116 feet to the property line of Frank & Jessie Hooker; thence through Hookers' property about 124 feet to the end of the vacation. Being about 1708 lineal feet or 0.32 mile in length.
