# Terry's Desk



As expected, spring quarter was busy as several projects continued and others got started. In April, we began new speed and curve ball bank studies utilizing a 90% safety grant from the Federal Highways Administration. Work continued on the Rover pipeline across the entire county, and there were lots of questions and concerns from our residents. We were successful in negotiating a temporary bridge modification and eventual replacement of a bridge on CR56 Cats Run. The plan included coordination with the Monroe County Engineer and three different townships for the detour route. We started planning for next winter by signing up for the ODOT salt bid. The last two winters have been mild, but we always have to prepare for the worst. We began yearly inspections of our 280 bridges, and began preparing our gravel roads for road oil dust control. April 27th we held our annual meeting with township trustees, followed by our employee safety meeting the next day.

In May we were busy with our normal maintenance activities, like cleaning ditches, mowing, and patching potholes. Pipeline work continued on the Rover and Markwest lines in several locations around the County. It seems we have had an unusual number of trees fall on our roads this spring. It's not clear if it's the wet spring weather, or dead ash trees, or just coincidence, but they're causing a lot overtime for our crews. We've also had our share of road slips pop up. Fortunately, the ones we've seen so far this spring are small enough for our crews to repair. Also in May, our GIS department switched to a new server, and the results were obvious, with much faster speeds. ODOT continued work on the Clark Road bridge, the Plainfield Road bridge, and SR 331 projects along I-70.

So far this year, OUPS has seen its volume increase to 541,725 to date.





In June we began spraying our guardrails for weed control. This work speeds up our mowing, helps extend the life of our guardrail, and improves safety by increasing the sight distance along our roads. We had one our bridges replaced on Crum Road in Wayne Township by Gulfport to facilitate a new well site, and they are currently replacing another bridge on CR16 Nixon Run. Our crews finished two slip repairs, one on CR 32 Kilgore Road and the other on CR 214 High Ridge Road. ODOT continued work on the new Commons Mall Road project, and completed the CR 2 Deep Run bridge replacement. Lastly, we signed a new contract with our bargaining unit that will last until 2020. It will be here before you know it! Stay safe and have an enjoyable summer.
