# ROAD PETITION.

For the Establishment of a Road in Richland Twp.

To the Board of Commissioners of Belmont County, Ohio:

The undersigned petitioners, resident freeholders of said County, respectfully represent that the public convenience requires the establishment of a county road on the line hereinafter described; and pray that your body will institute and order the proper proceedings in the premises to locate and establish such road, to-wit: Beginning at a point in a certain road, about 42.50 rods south of a beech tree (known as a station marking the north-west corner of the Thomas Harvey farm, which is located in the south-east quarter of Section 25, Township 6 and Range 3.) thence in a southerly direction, following its entire distance, as near as may be practicable, a run which crosses the lands of Elmer Ault, Thomas Harvey, Jacob Giffin, and William Harvey, to a point in a county road (commissioners Road Record, Book 2, Page 217), a few feet southeast from where said run unites with a larger creek, near the south-east corner of the lands of J. R. Giffin.

# Report of Viewers.

To the Board of Commissioners of Belmont County, Ohio:

In obedience to your order, issued at your June 2nd session, A. D. 1892, we the undersigned, Viewers appointed under said order, met with John A Bond Surveyor, at home of T J Harvey on June 18th, 1902 and were severally sworn to discharge, faithfully and impartially, the duties required of us in said order.

If any Viewer is unable to attend here state by whom the vacancy was filled.

John Lochary and Thos Harvey were selected by us as chain carriers, and Elmer Harvey as a marker, who were also duly sworn.

We then proceeded to view said proposed County road on the line described in your order, and caused the same to be surveyed, "as prayed for in the petition, or as near the same as in our opinion a good road can be made at a reasonable expense, taking into consideration the utility, convenience, and inconvenience and expense which will result to individuals as well as the public," by the establishment of said road as follows:

Beginning at a point in a certain road about 42.50 rods south of a beech tree known as a station marking the Northwest corner of Thomas Harvey farm which is located in the S. E. Qr of Sec. 25 Twp. 6 R. 3 as mentioned in petition. Commenced at Sta. 1 a stone planted in center of Road from which a cross on solid rock in creek bed bears S 5° 40' E 28 1/2 links and a maple 5" in diameter bears S 45° 40' W 39 links, thence from Sta. 1 S 40° 48' E 4.14 poles; thence S 12° 58' E 14.00 poles; thence S 12° 01' E 19.54 poles; thence S 12° 31' E 5.25 poles, thence S 16° 35' W 12.51 poles, thence S 1° 26' E 11.56 poles; thence S 12° 50' E 6.76 poles; thence S 12° 41' W 22.22 poles; thence S 42° 44' W 6.37 poles; thence S 27° 19' W 7.12 poles; thence S 30° 34' W 7.16 poles; thence S 3° 24' W 13.24 poles; thence S 24° 31' E 5.30 poles; thence S 14° 04' W 21.60 poles; thence S 25° 02' W 3.58 poles; thence S 20° 24' W 15.40 poles; thence S 32° 09' W 9.48 poles; thence S 16° 19' W 9.90 poles; thence S 24° 49' W 12.53 poles; thence S 30° 57' W 4.18 poles; thence S 13° 42' W 7.08 poles to the end a stone planted at intersection of roads.

We would respectfully report that the said County road ought to be established for the following reasons:

Practically there is no grades, no bridges and can be constructed with light expense; will shorten the distance considerable between Franklin and St. Clairsville.

We have also determined that the public convenience requires that such County road shall be established 30 feet in width.


