For a Location Road in Warren Oh

To the Board of Commissioners of Belmont County, Ohio:

The undersigned petitioners, resident freeholders of said county, respectfully represent that the public convenience requires the Establishment of a County road on the line hereinafter described; and pray that your body will institute and order the proper proceedings in the premises to Establish

such road, to-wit: Beginning at the County line in Warren Oh at a stake marked "A" between the lands of James Kemmon & the Heirs of Thos Kemmon, thence in an Easterly direction through the lands of James Kemmon and along the line between the lands of John Galloway Sr and Heirs of Samuel Campbell to intersect the County road (at or near a beech tree) leading to Barnesville being the eastern terminus of said Contemplated Road

The Conditions of the above Obligations are Such, That, whereas application has been made to the board of Commissioners of said Belmont County for the establishment of a County road on the following line, to-wit:

Beginning on the County line in Warren Township at a stake marked "A" between the lands of James Kemmon and heirs of Thos Kemmon thence in an Easterly direction through the lands of James Kemmon and along the line between the lands of John Galloway Sr and heirs of Samuel Campbell to intersect the County road (at a beech tree) leading to Barnesville and there to terminate

Now if the said applicants shall pay into the Treasury of the said county the amount of all costs and expenses accruing thereon, in case the prayer of said petitioners shall not be granted, or when the proceedings had in pursuance thereof shall not be finally confirmed and established, then this obligation to be void; otherwise to be in full force in law.

Beginning for the survey of said road in the center of the end of a road in *Meigs* County and on the line between said Counties at a point witnessed by a cross cut on a sand stone rock, bearing *30 N 12 1/2 W* thence on the lands of *James Keunon* *41 3/4 E. 24 P* *72 E 10 P.* *67 1/2 E P* to a line between *Keunon* and some body else thence with said line *87 3/4 E 32 P + 18* links to a *beech tree* standing in the edge of the road leading to *Barnsville*.

To the Board of Commissioners of Belmont County, Ohio:




To the Board of Commissioners of Belmont County, Ohio:

Wm Colvin and Mitchell Lowndra were selected by us as chain carriers, and Israel Sidwell as a marker, who were also duly sworn.

We then proceeded to view said proposed County Road on the line described in your order, and caused the same to be surveyed "as prayed for in the petition, or as near the same as in our opinion a good road can be made at a reasonable expense, taking into consideration the utility, convenience, and inconvenience and expense which will result to individuals as well as the public," by the Alteration of said road as follows:

We would respectfully report that the said Alteration ought to be made for the following reasons: that a Steam Saw mill so near the old road causes the travel to have to go up a steep bank also avoid a very swampy place in the old road + shortens the distance with a better grade. Near of opinion that petitioners should pay half the Compensation and be at expense of opening road ex Stone work for bridge across Creek

We have also determined that the public convenience requires that such Alteration shall be established thirty feet in width.
