To the Board of Commissioners of Belmont County, Ohio:

In the matter of the alteration of the county road leading from Fairview to Barnesville by way of Catharine Beardmore:

The undersigned petitioners resident freeholders of said county of Belmont, respectfully represent that the public convenience requires that the county road leading from Fairview to Barnesville, by way of Catharine Beardmore, in said County, should be altered between the following points, to wit, at a point on said road at the foot of the James Cowgill hill on the north side thereof, at a stake marked "B"; near a walnut log, and where said road joins with the road leading from Fairview to Barnesville, by way of Benjamin Giffee, at the joining of said two roads, at a stake marked "A"; Said change beginning on the first mentioned road at the foot of the said James Cowgill hill on the north side thereof, at a stake on said road marked "B"; thence running in a south-westerly direction through the lands of Job Johnson, deceased about 45 rods to a stake marked "C"; thence in a south-westerly direction through said lands of Job Johnson, deceased about 8 rods to the road leading from Fairview to Barnesville by way of Benjamin Giffee at a stake marked "D" on said road near a hay stack on the Johnson lands; thence with said last mentioned road to said stake marked "A". Said petitioners therefore ask that the necessary proceedings may be had to establish such alteration according to law. Said petitioners ask that that part between said points on the old and present road, to wit, the road first mentioned in this petition, be also vacated.

J.L. Murphy and Homer H Neptune were selected by us as chain carriers, and J.W. Hunt as a marker, who were also duly sworn.

We then proceeded to view said proposed Alteration on the line described in your order, and caused the same to be surveyed, "as prayed for in the petition, or as near the same as in our opinion a good road can be made at a reasonable expense, taking into consideration the utility, convenience, and inconvenience and expense which will result to individuals as well as the public," by the Establishment of said road as follows:
