

ROAD PETITION

For the alteration of a Road in Smith and Richland Township,
 Improvement No. 242 Petitioned for by R. F. Denham and Others
 TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the alteration of a Public Road on the line hereinafter described and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning

At a point in the Glencoe-Warnock road at or near the line between the lands of Steve Karapandza and Mrs. Jennie Stitt, and in the S. W. Quarter of Section 6, Township 6 and Range 4, in Smith Township in said county; thence in a northwesterly direction through the land of Steve Karapandza for a distance of about 500 yards by the easiest grade to a point in the road leading from said Glencoe-Warnock road north to St. Clairsville; thence with said road leading to St. Clairsville for a distance of about one and one-half miles to the top of what is known as McBride's Hill; thence leaving said road in northwesterly direction through the lands of C. W. Troll in Richland Township and by the easiest grade for a distance of about 300 yards to the improved road leading from Glencoe and known as the St. Clairsville-Glencoe Road.
