For the construction of a Road in Washington & York Township,
 Improvement No. 243 Petitioned for by W. J. Durigg and Others
 TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the construction of a Public Road on the line hereinafter described and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning Near the residence of L. N. Walters on County Road #120, on Clover Ridge, in Washington Township, and leading thence in a south east direction thru lands of Wm. Walters, Herman Walters, Lawrence Walters, Christian Walters and A. C. Frolely to Monroe County line, a County Highway, and to re-locate and grade the same as your judgment may approve.

The said road is much travelled and is in the line of Rural Mail Route #1 from Powhatan Point Post Office.

the same was this day considered by the Commissioners, and it appearing that said petition is regular and in conformity to law, and that the said W. J. Durigg has filed herein a bond as required by law. It is ordered that the 22nd day of May 1928, at 10.00 o'clock A.M., be fixed as a date to view the same, at which date they will meet at the commencing point and go over the route of said proposed road.

They also fixed the 11th day of June 1928, at 10.00 o'clock A.M., as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the Bellaire Daily Leader a newspaper published and having a general circulation in the County of Belmont.

Durigg and others, in the Bellaire Daily Leader, a newspaper of general circulation in said county required by law, and the former orders of this Board, the Commissioners on this 22nd day of May, 1928, met at the time and place in said notice designated and did view the route of said proposed road improvement, and considering such improvement to be of sufficient public importance, it is ordered that the County Surveyor make a plat and survey of the same and report to the Board in writing on or before the 11th day of June, 1928, the time set for the hearing, and shall set forth in said report his opinion either for or against the granting of such proposed improvement, accompanied with a statement of the estimated compensation and damages due each person, firm or corporation whose land is to be taken if the proposed improvement is established. Such report shall also state the width of said improvement, which shall not be less than thirty feet nor more than sixty feet, and also recommend any changes in the improvement, which in his judgment, should be made.
