The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience requires the..... establishing.....
of a Public Road on the line hereinafter described and pray that you will institute and order the proper proceedings for said improvement, to-wit: Beginning
 In the town of Neffs, County of Belmont, State of Ohio.

First: Beginning at the intersection of Ohio Street with the west end of Harrison Street, thence east on Harrison Street to the Dixon Road, together with the streets connecting Belmont Street with Harrison Street.

Second: Beginning at a stone at the west end of St. Mary Avenue; thence east on St. Mary Avenue to the Dixon Road, together with the streets connecting Harrison Street with St. Mary Avenue.

Third: Beginning with the intersection of Belmont Street with the Dixon Road, thence east on Belmont Street to East Street, thence south on East Street to the Bellaire-Neff concrete road.

(The above described streets and alleys have been platted and dedicated and opened to public use.)

Fenton has filed herein a bond as required by law. It is ordered that the 4th day of December 1928, at 10.00 o'clock A.M., be fixed as a date to view the same, at which date they will meet at the commencing point and go over the route of said proposed road.

They also fixed the 7th day of January 1929, at 10.00 o'clock A.M., as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the Bellaire Daily Leader a newspaper published and having a general circulation in the County of Belmont.

Fenton and others, in the Bellaire Daily Leader, a newspaper of general circulation in said county required by law, and the former orders of this Board, the Commissioners on this 9th day of April 1929, Con't from December 4, 1928. met at the time and place in said notice designated and did view the route of said proposed road improvement, and considering such improvement to be of sufficient public importance, it is ordered that the County Surveyor make a plat and survey of the same and report to the Board in writing on or before the 7th day of January 1929, Con't till September 9, 1929. the time set for the hearing, and shall set forth in said report his opinion either for or against the granting of such proposed improvement, accompanied with a statement of the estimated compensation and damages due each person, firm or corporation whose land is to be taken if the proposed improvement is established. Such report shall also state the width of said improvement, which shall not be less than thirty feet nor more than sixty feet, and also recommend any changes in the improvement, which in his judgment, should be made.

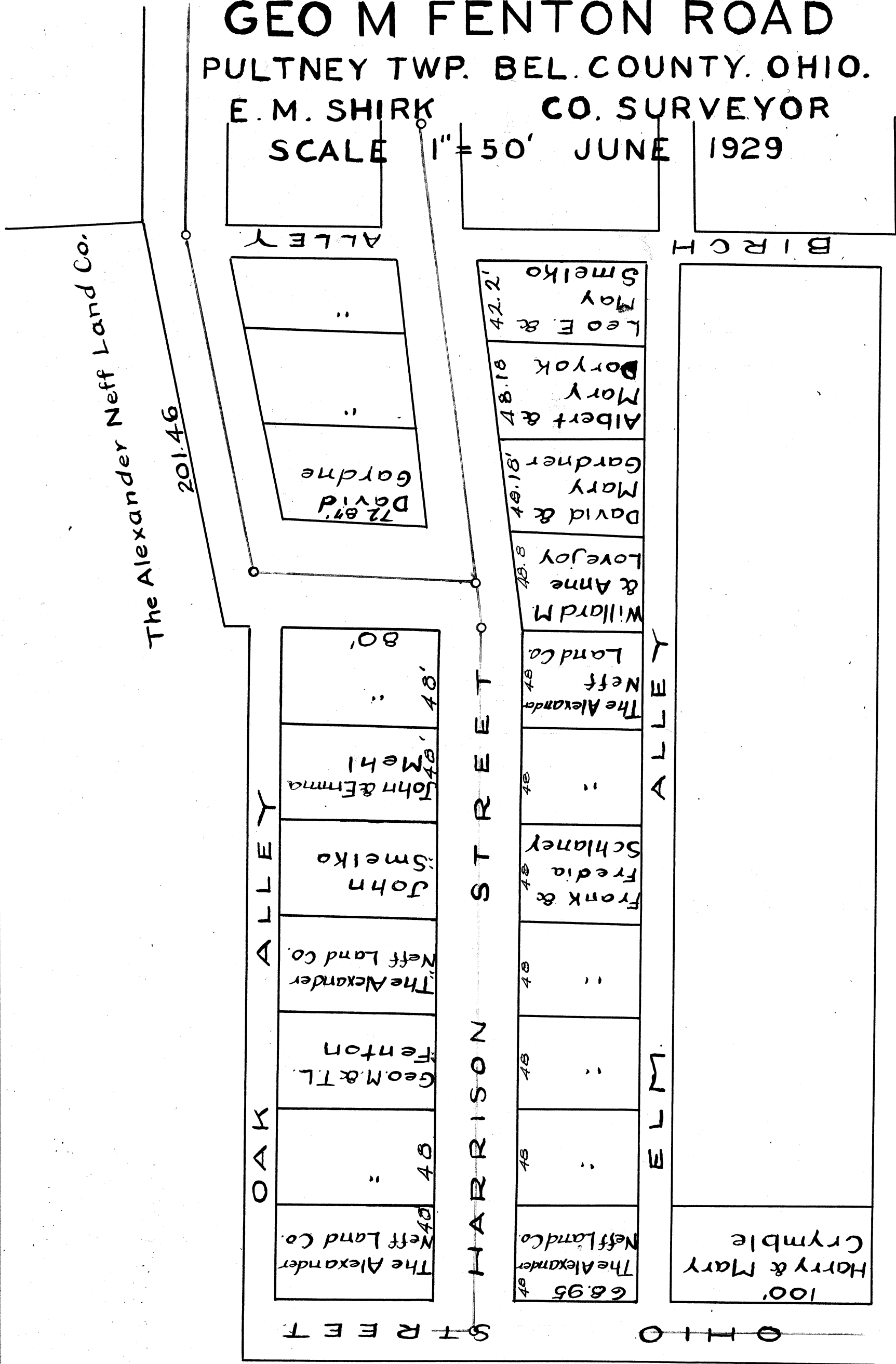

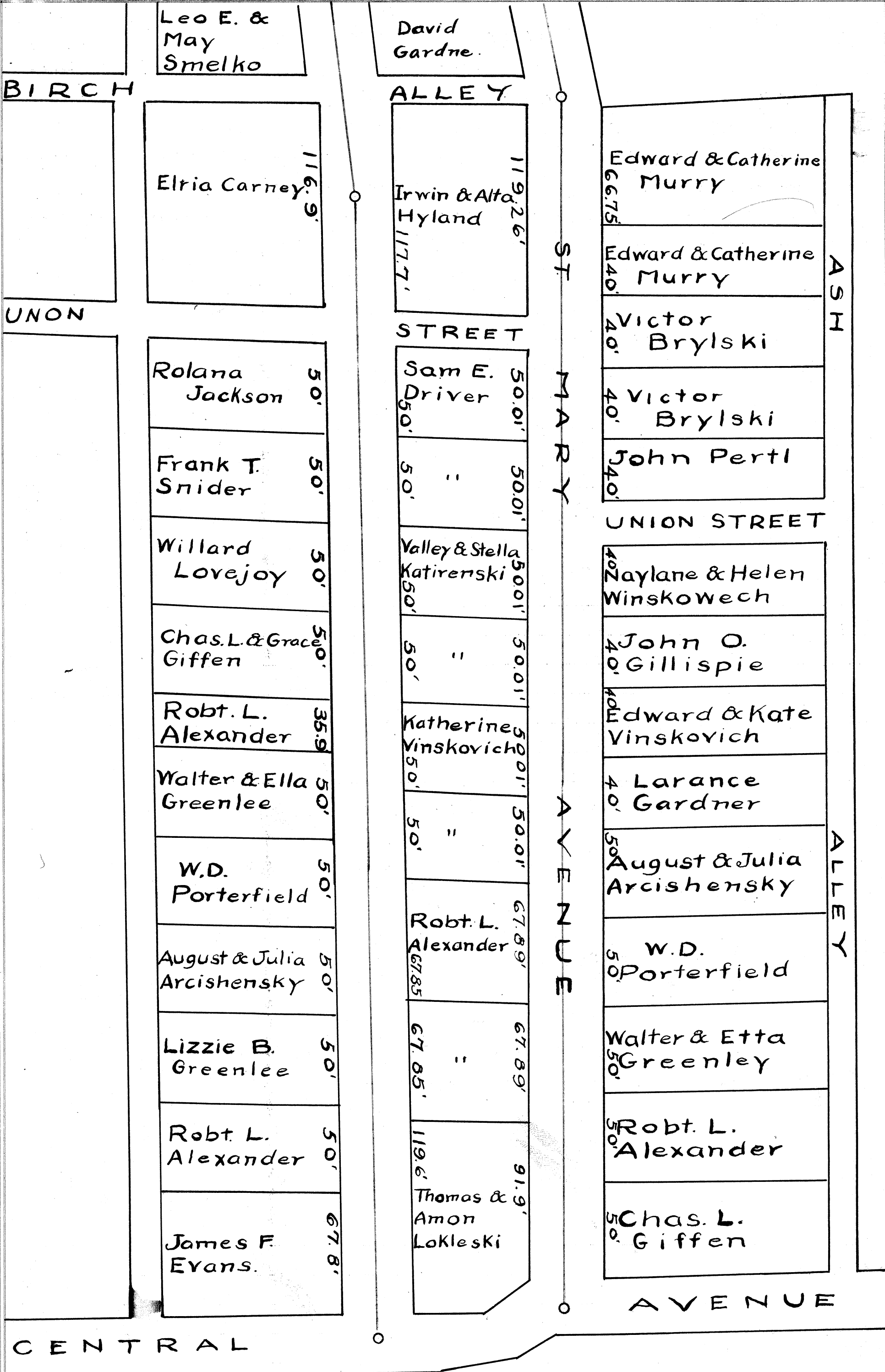
GEO M FENTON ROAD
