For the establishment of a Road in Smith Township,

 TO THE BOARD OF COMMISSIONERS OF BELMONT COUNTY, OHIO:

The undersigned petitioners resident freeholders of said County, residing in the vicinity of the proposed improve-

 (Being in Section 12, Township 6 and Range 4 in said Township); thence directly south from said
 beginning point thru the lands of Fedor to a point intersecting with the improved
Glencoe-Lamira Road, Section "A".

 from the said improved Glencoe-Lamira Road to the said Fulton Hill.

Walker Fulton and others, have filed a petition in the office of the Commissioners of the County, on the 1st day of July 1929 for the establishment of a

the same was this day considered by the Commissioners, and it appearing that said petition is regular and in conformity to law, and that the said Walker Fulton has filed herein a bond as required by law. It is ordered that the 30th day of July 1929, at 10.00 o'clock A.M., be fixed as a date to view the same, at which date they will meet at the commencing point and go over the route of said proposed road.

They also fixed the 19th day of August 1929, at 10.30 o'clock A.M., as the date for final hearing at the office of the County Commissioners at which time it will be considered whether said improvement will be granted, and if granted, a time fixed for hearing claims for compensation and damages.

It is further ordered, that notice of the time and place of both such view and hearing be given by publication once a week for three consecutive weeks in the Bellaire Democrat a newspaper published and having a general circulation in the County of Belmont.

Shry Commissioners and _____, Auditor and Secretary of the Board, and it appearing that in the matter of the establishment of the public road, petitioned for by Walker Fulton and others, due and proper notice, proof of which is on file in this office, having been given of the time and place of meeting, to view road petitioned for by Walker Fulton and others, in the Bellaire Democrat, a newspaper of general circulation in said county required by law, and the former orders of this Board, the Commissioners on this 30th day of July, 19 29, met at the time and place in said notice designated and did view the route of said proposed road improvement, and considering such improvement to be of sufficient public importance, it is ordered that the County Surveyor make a plat and survey of the same and report to the Board in writing on or before the 19th day of August, 19 29, **Con't till January 20, 1930.** the time set for the hearing, and shall set forth in said report his opinion either for or against the granting of such proposed improvement, accompanied with a statement of the estimated compensation and damages due each person, firm or corporation whose land is to be taken if the proposed improvement is established. Such report shall also state the width of said improvement, which shall not be less than thirty feet nor more than sixty feet, and also recommend any changes in the improvement, which in his judgment, should be made.

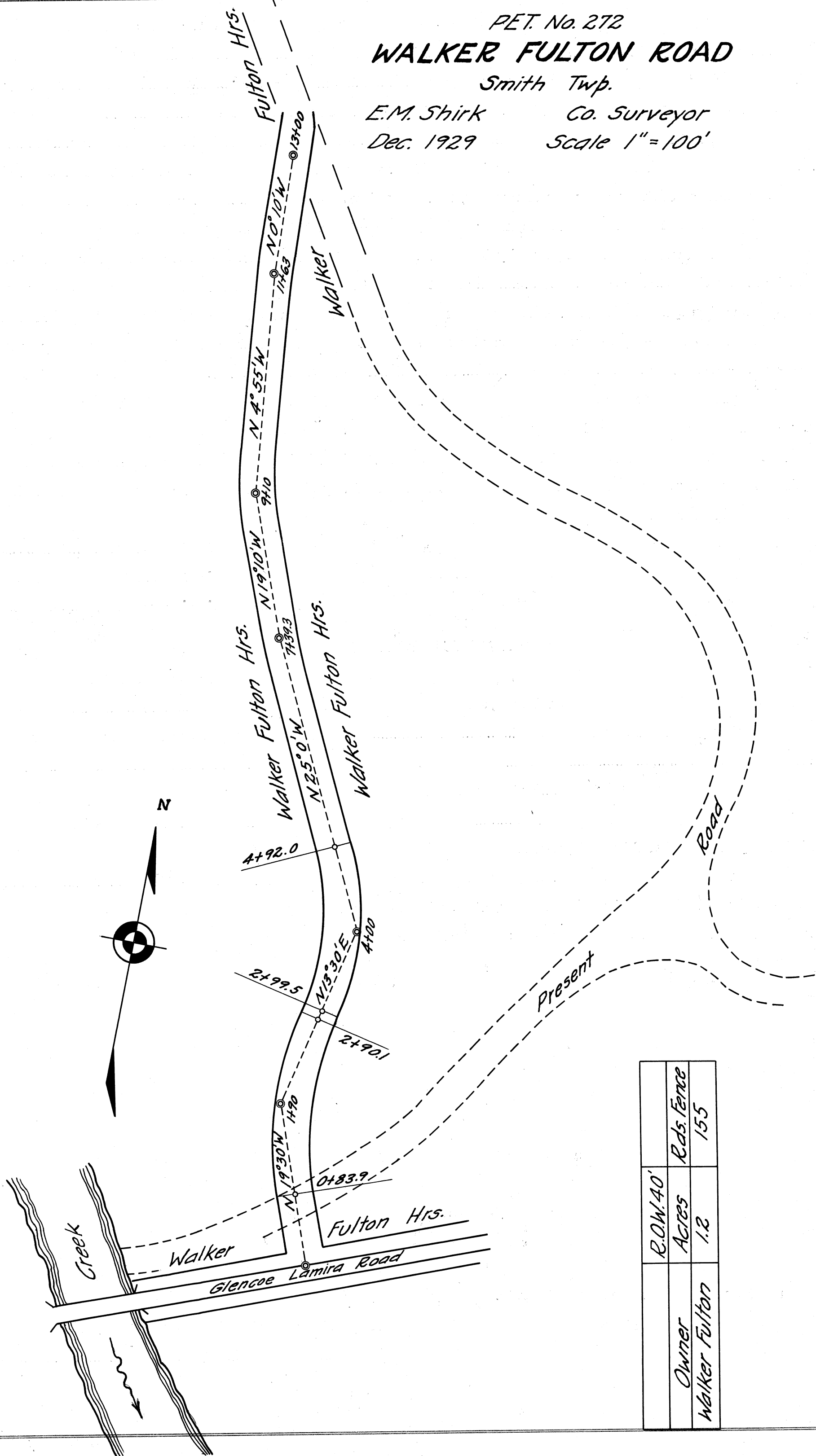
