The undersigned petitioners, freeholders of said County residing in the vicinity of the proposed improvement hereinafter described, respectfully represent that the public convenience and welfare require the vacating of a portion of Warren T-175 a Public Road on the line hereinafter described, and make application to you to institute and order proper proceedings in the premises, for vacating such road, the same not being a road on the State Highway System.

The following is the general route and termini of said road:

Beginning at a point on Warren Twp Rd 175 which is 860.0 feet from the intersection of Twp Rd 174 and Twp Rd 175 located in Warren Section 6 T-8 R-6 thence in a southeasterly direction with the centerline of Twp Rd 175 passing into Warren Section 5 T-8 R-6 to the Goshen Twp. line. The intent of this petition is to vacate all but the initial 860.0 feet of Warren Twp Rd 175 from its intersection with Warren Twp Rd 174 to the Warren/Goshen line.

such termini, and at sufficient other points on the right of way lines so that the bounds of the proposed improvement may be discernible to property

day of February, 2002, the date fixed for the final hearing, setting forth his opinion either for or against said proposed

On failure of such benefited landowners to pay such compensation and damages as may be adjudged against them by the day of 19 it is hereby determined that said proposed improvement be abandoned. It is further ordered that there be included in this order and made a part hereof the accompanying schedule setting forth the names if such benefited landowners, a pertinent description of such land and a statement of the amount of such compensation and damages to be paid by the owner, or owners, of each parcel of such land; and be it further~~

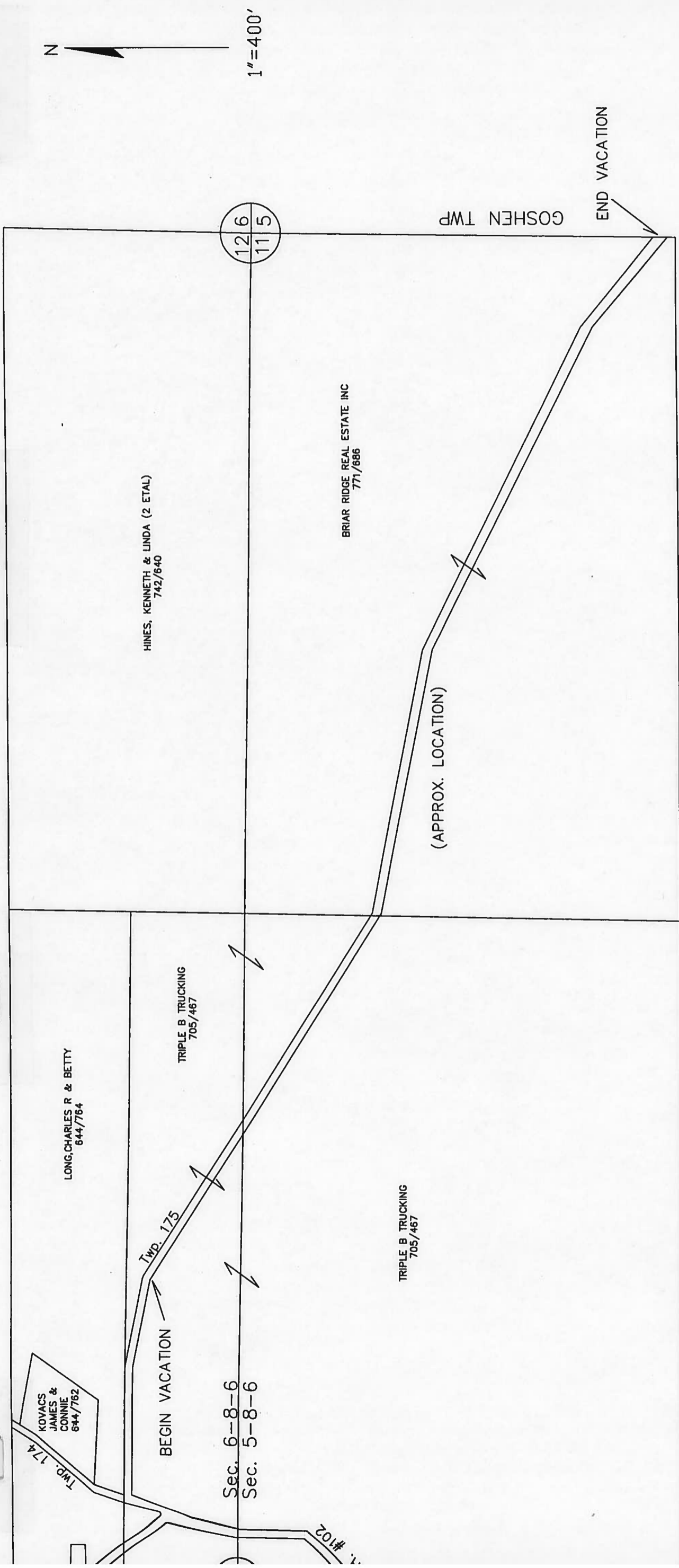
